RELEASE OF INTELLECTUAL PROPERTY SECURITY AGREEMENT

WHEREAS, pursuant to that certain Intellectual Property Security Agreement, dated as of February 19, 2017, that was recorded February 25, 2017, at the United States Patent and Trademark Office on Reel: 4970; Frame: 0294 (the "Trademark Security Agreement"), RADIUS INTELLIGENCE, INC., a Delaware corporation ("Grantor"), pledged and granted to VENTURE LENDING & LEASING VI, INC. and VENTURE LENDING & LEASING VII, INC., both Maryland corporations (sometimes referred to herein individually or together as the "Secured Party"), to secure the Obligations, a Lien on and security interest in the trademark registrations listed on Schedule I attached hereto (the "Trademark Collateral"); and

WHEREAS, Grantor has requested and the Secured Party has agreed to provide this Release of Trademark Security Agreement to confirm the release, relinquishment and discharge of its continuing security interest in the Trademark Collateral.

NOW, THEREFORE, in consideration of and in exchange for good and valuable consideration, the Secured Party hereby agrees as follows:


1. Defined Terms. All capitalized terms used but not otherwise defined herein have the meanings given to them in the Trademark Security Agreement or the Loan and Security Agreement referred to therein.

2. Release of Security Interest. The Secured Party hereby, without any representation and warranty and without any recourse (a) terminates the Liens and security interests created under the Trademark Security Agreement in the Trademark Collateral, (b) releases its security interest in the Trademark Collateral, (c) discharges any and all rights, title and interest it has in and the security interest granted to the Secured Party in the Trademark Collateral, and (d) terminates the Trademark Security Agreement except for any provisions therein that expressly survive termination.


