RELEASE OF SECURITY INTEREST IN TRADEMARKS

THIS RELEASE OF SECURITY INTEREST IN TRADEMARKS (this “Release”) is made as of October 11, 2019, by **PNC BANK, NATIONAL ASSOCIATION**, a national banking association, as Agent for itself and the other Lenders (“Agent”).

RECITALS:

WHEREAS, Alliance Metaversal Studio LLC, a Delaware limited liability company (“Pledgor”), and Agent, entered into that certain Intellectual Property Security Agreement dated as of May 31, 2012 (the “Security Agreement”), pursuant to which Pledgor granted to Agent a security interest in and to and lien upon certain trademarks and related rights owned by Pledgor;

WHEREAS, an executed copy of the Security Agreement was recorded in the United States Patent and Trademark Office on June 29, 2012 at Reel 4815, Frame 0497;

WHEREAS, Pledgor has paid off its obligations to Agent under the Loan Agreement; and

WHEREAS, Pledgor has requested that Agent release, and Agent has agreed to release, its lien on all trademarks pledged pursuant to the Security Agreement.

NOW, THEREFORE, for good and valuable consideration, receipt of which is hereby acknowledged, Agent hereby agrees as follows:

AGREEMENT:


Capitalized terms used but not defined herein shall have the respective meanings given thereto in the Security Agreement.

Agent hereby releases and terminates all right, title and interest pledged, hypothecated, assigned, transferred, deposited and granted to it by Pledgor pursuant to the Security Agreement in all trademarks, including, without limitation, the trademarks identified on Schedule A annexed hereto (collectively, the “Released Collateral”), and all liens, security interests, charges or other encumbrances in favor of Agent in the Released Collateral shall hereby terminate and revert to Pledgor and all right, title and interest of Agent in the Released Collateral will hereby cease, terminate and become void.
