**TERMINATION AND RELEASE
OF GRANT OF SECURITY INTEREST (TRADEMARKS)**

TERMINATION AND RELEASE OF GRANT OF SECURITY INTEREST (TRADEMARKS) (this "Release"), dated as of October 8, 2019, by **WEBSTER BANK, NATIONAL ASSOCIATION** (the "Administrative Agent") in favor of **CME, LLC**, a Delaware limited liability company (the "Grantor").

WHEREAS, pursuant to the terms of that certain Security Agreement, dated as of December 12, 2012 (as amended supplement or otherwise modified from time to time, the "Security Agreement"), among the Grantor, the other parties thereto and the Administrative Agent, and that certain Grant of Security Interest (Trademarks) (the "Trademark Security Agreement"), dated as of December 12, 2012, by the Grantor in favor of the Administrative Agent, the Grantor granted to the Administrative Agent a security interest in and to all of the right, title and interest of the Grantor in and to the trademarks listed on Schedule A attached hereto, which trademarks are registered in the United States Patent and Trademark Office (the "Trademarks"), together with the goodwill of the business symbolized by the Trademarks, and all proceeds thereof, including, without limitation, from any and all causes of action which may exist by reason of infringement thereof (together with the Trademarks, the "Collateral"), to secure the prompt payment, performance and observance of the Obligations (as defined in the Security Agreement);

WHEREAS, the Administrative Agent wishes to terminate and release its security interests in and to all of the right, title and interest of the Grantor in and to the Collateral, including the Trademarks identified on Schedule A attached hereto; and

WHEREAS, the Trademark Security Agreement was filed on December 20, 2012 with the United States Patent and Trademark Office in Reel: 4924; Frame: 0208.

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Administrative Agent hereby terminates, releases and discharges fully its security interests in and to all of the right, title and interest of the Grantor in and to the Collateral, as granted under the Security Agreement and the Trademark Security Agreement, and reassigns and transfers to the Grantor all right, title and interest that the Administrative Agent may have in the Collateral, and terminates the Trademark Security Agreement. The Administrative Agent hereby authorizes the Grantor, or the Grantor's authorized representative or designee, to record this Release with the United States Patent and Trademark Office.
