**TRADEMARK RELEASE AND REASSIGNMENT**

THIS TRADEMARK RELEASE AND REASSIGNMENT (this “Trademark Release and Reassignment”) is made as of October 15, 2019, by U.S. BANK NATIONAL ASSOCIATION, as Collateral Agent (“Secured Party”). Capitalized terms used but not defined herein shall have the same meanings assigned to such terms in the Security Agreement (as defined below).

WITNESSETH:

WHEREAS, TruckPro, LLC, a Delaware limited liability company (the “Grantor”) and Secured Party were parties to that certain Grant of a Security Interest – Trademarks, dated as of September 11, 2018 (the “Security Agreement”) pursuant to which Grantor granted a security interest (the “Security Interest”) to Secured Party in certain Trademarks and Collateral (each as defined therein) as security for certain obligations owing by Grantor to Secured Party, including the Trademarks set forth on Schedule A attached hereto;

WHEREAS, the Security Agreement was recorded by the Trademark Division of the United States Patent and Trademark Office on September 20, 2018, at Reel 6461, Frame 0164; and

WHEREAS, Grantor has requested that Secured Party terminate and release its Security Interest in the Trademarks and Collateral and reassign any and all rights in the same to Grantor.

NOW THEREFORE, for good and valuable consideration, receipt and sufficiency of which are hereby acknowledged, Secured Party hereby terminates, releases and discharges its Security Interest in all of Grantor’s right, title and interest in and to the Trademarks and Collateral.


