CONFIRMATORY TRADEMARK ASSIGNMENT

THIS CONFIRMATORY TRADEMARK ASSIGNMENT ("Assignment"), dated *nunc pro tunc* as of July 1, 2018, is made by and between **Flint Group US LLC**, a Texas limited liability company having a principal place of business at 14909 North Beck Road, Plymouth, Michigan, 48170 on its behalf and on behalf of its predecessors as described in detail below ("Assignor" or "Flint Group US LLC Texas") and **Flint Group Packaging Inks North America Holdings LLC**, a Texas limited liability company having a principal place of business at 14909 North Beck Road, Plymouth, Michigan, 48170 ("Assignee" or "Flint Group Packaging Inks"), and is effective as of the aforementioned date.

1. Flint Ink Corporation was a corporation organized under the laws of the State of Michigan ("Flint Ink Corporation"). In a Certificate of Amendment to the Articles of Incorporation filed with the State of Michigan effective February 9, 2006, Flint Ink Corporation changed its name to Flint Group Incorporated ("Flint Group Incorporated").
2. In a Certificate of Conversion filed with the State of Michigan effective September 5, 2014, Flint Group Incorporated was converted to a newly formed Michigan limited liability company named Flint Group US LLC ("Flint Group US LLC Michigan").
3. In a Certificate of Conversion filed with the State of Michigan effective June 29, 2018, Flint Group US LLC Michigan was converted to a newly formed Texas limited liability company named Flint Group US LLC ("Flint Group US LLC Texas").
4. In accordance with the applicable provisions of the Michigan Business Corporation Act and the Texas Business Organizations Code, because of the name change and conversions identified in Paragraphs 1-3 above, among other effects, all right, title and interest to all trademarks owned by Flint Ink Corporation, Flint Group Incorporated, and Flint Group US LLC Michigan continued to be owned by Flint Group US LLC Texas without further act or deed, or any transfer or assignment having occurred. Accordingly, as a result of the name change and conversions identified in Paragraphs 1-3 above, Flint Group US LLC Texas became the owner of all such trademarks.
5. Flint Group US LLC Texas entered into an Agreement and Plan of Merger dated as of June 29, 2018 and effective July 1, 2018 ("Plan of Merger") with two affiliated entities, Flint Group Packaging Inks North America Holdings LLC, a Texas limited liability company ("Flint Group Packaging Inks Holdings"), and Flint CPS Inks Holdings LLC, a Texas limited liability company ("Flint CPS Inks Holdings"). A Certificate of Merger was filed with the State of Texas effective July 1, 2018.
6. The Plan of Merger provided that, as the result of the merger described therein (the "Merger"), (a) certain of the property and assets, and all right, title and interest in and benefits from such property and assets, whether fixed or contingent (collectively defined in the Plan of Merger as "Property"), of or owned by Flint Group US LLC Texas would be allocated to and vested in Flint CPS Inks Holdings, and the rest of the

Property of or owned by Flint Group US LLC Texas would be allocated to and vested in Flint Group Packaging Inks Holdings, (b) Flint CPS Inks Holdings and Flint Group Packaging Inks Holdings would survive and continue to exist, and (c) Flint Group US LLC Texas would cease to exist.

7. In accordance with the applicable provisions of the Texas Business Organizations Code, because of the Merger, among other effects, all right, title, and interest to all trademarks and the goodwill in the trademarks owned by Flint Group US LLC Texas were allocated to and vested in one or both of Flint CPS Inks Holdings and Flint Group Packaging Inks Holdings.
8. Pursuant to the Plan of Merger, Assignor Flint Group US LLC Texas assigned to Assignee Flint Group Packaging Inks Holdings, and Assignee accepted from Assignor, all right, title and interest in and to the trademarks listed in Exhibit A attached hereto, including the trademark registrations and applications, the associated common law rights therein, and the goodwill of the business symbolized thereby ("Trademarks").
9. Assignor Flint Group US LLC Texas hereby confirms the assignment to Assignee Flint Group Packaging Inks Holdings of all of Assignor's right, title and interest in and to the Trademarks listed in Exhibit A, including the trademark registrations and applications, the common law rights therein, any and all rights provided by international conventions and treaties, and the goodwill associated therewith.
10. Attached hereto as Exhibit B is a complete and correct copy of each of (a) the Certificate of Amendment to the Articles of Incorporation effective February 9, 2006, (b) the Certificate of Conversion effective September 5, 2014, (c) the Certificate of Conversion effective June 29, 2018, and (d) the Certificate of Merger effective July 1, 2018.
