**TERMINATION AND RELEASE OF  
TRADEMARK SECURITY AGREEMENT**

This **TERMINATION AND RELEASE OF TRADEMARK SECURITY AGREEMENT** (this "*Termination and Release*") is granted as of October 15, 2019 by **SILICON VALLEY BANK** (the "*Assignee*"), in favor of **RADIXX SOLUTIONS INTERNATIONAL, INC.**, a Delaware corporation (the "*Grantor*").

**WHEREAS**, the Grantor executed and delivered a Trademark Security Agreement dated as of December 9, 2016 (as amended, restated, supplemented or otherwise modified prior to the date hereof, the "*Grant*") granting the Assignee a security interest in and lien on certain trademarks and trademark applications ("*Trademarks*") described therein, which was recorded with the United States Patent and Trademark Office ("*USPTO*") on January 5, 2017, at Reel 5958, Frame 0588;

**NOW, THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Assignee hereby:


1. terminates the Grant and releases, terminates and discharges all liens and security interests in Grantor's right, title and interest in, to and under the Trademarks, and all goodwill associated therewith, including those certain Trademarks identified in Schedule I hereto; and
2. authorizes and requests that this Termination and Release be recorded at the USPTO.

THIS TERMINATION AND RELEASE AND THE RIGHTS AND OBLIGATIONS OF THE PARTIES HEREUNDER SHALL BE GOVERNED BY, AND SHALL BE CONSTRUED AND INTERPRETED IN ACCORDANCE WITH, THE LAWS OF THE STATE OF NEW YORK.
