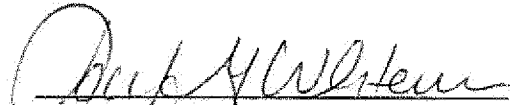
Diversified Port Holdings LLC, a limited liability company organized under the Limited Liability Company Act of the State of Delaware (the "Company"), hereby states and certifies:
