Trademark Purchase and Assignment Agreement

This Trademark Purchase and Assignment Agreement (hereinafter referred to as the "Agreement") is made as of October 14, 2019 (hereinafter referred to as the "Effective Date") between Henrik Friis Juhl, an individual having an address at Kijangwani Street 13, Chukwani, United Republic of Tanzania (hereinafter referred to as the "Assignor"), and VERVIG LLC, a limited liability company having an address at 3825 Lancaster Pike, Suite 3, Wilmington, Delaware 19805, the United States of America (hereinafter referred to as the "Assignee").

WHEREAS, the Assignor is the owner of the following trademarks for which applications to register have been filed:

- (i) the trademark "VERVIG LIFE" for which the US trademark application Serial No. 88302994 has been filed;
- (ii) the trademark "VERVIG LIFE" for which the US trademark application Serial No. 88302960 has been filed;
- (iii) the trademark "VERVIG LIFE" for which the US trademark application Serial No. 88302844 has been filed;
- (iv) the trademark "VERVIG LIFE" for which the US trademark application Serial No. 88302798 has been filed; and
- (v) the trademark "VERVIG LIFE" for which the US trademark application Serial No. 88301265 has been filed (hereinafter collectively referred to as the "Trademarks").

WHEREAS, the Assignee wishes to acquire the Assignor's rights in the Trademarks.

IT IS HEREBY AGREED as follows:

1. The Assignee agrees to pay to the Assignor the sum of USD 5,000 (five thousand U.S. dollars). In exchange, the Assignor hereby conveys, transfers, and assigns to the Assignee all of the Assignor's right, title, and interest of whatever kind in the Trademarks, together with
 - A) the goodwill of the business relating to the products and services on which the Trademarks are used,
 - B) all income, royalties, and damages hereafter due or payable to the Assignor with respect to the Trademarks, including without limitation, damages, and payments for past or future infringements and misappropriations of the Trademarks, and
 - C) all rights to sue for past, present and future infringement or misappropriations of the Trademarks.
2. The Assignor further covenants that it will take all actions that may be necessary for securing, completing, or vesting in the Assignee full right, title, and interest in the Trademarks and their related property.

IN WITNESS WHEREOF, the Assignor and the Assignee have duly executed this Agreement on the Effective Date.
