**PARTIAL RELEASE OF SECURITY INTEREST IN TRADEMARKS**

This **PARTIAL RELEASE OF SECURITY INTEREST IN TRADEMARKS**, dated as of October 17, 2019 (the "Release"), is made by JPMORGAN CHASE BANK, N.A., in its capacity as collateral agent (in such capacity, the "Collateral Agent"), in favor of LIVE NATION WORLDWIDE, INC., a Delaware corporation (the "Grantor"). All capitalized terms used but not otherwise defined herein have the meanings assigned to them in the Security Agreement (as defined below).

**WITNESSETH**

WHEREAS, Grantor, the Collateral Agent, and other parties thereto entered into that certain Security Agreement, dated as of August 16, 2013 (as amended, amended and restated, supplemented or otherwise modified from time to time, the "Security Agreement");

WHEREAS, pursuant to the Security Agreement, the Grantor executed the Grant of Security Interest in Trademarks, dated as of August 16, 2013 (the "Trademark Security Agreement") and recorded with the U.S. Patent and Trademark Office on August 19, 2013 at Reel/Frame No. 5093/0283, pursuant to which the Grantor granted to the Collateral Agent for the benefit of the Secured Parties a Lien on and continuing security interest in and to all of its right, title and interest in, to and under all the Applicable Collateral (as defined in the Trademark Security Agreement).

WHEREAS, the Collateral Agent has agreed to release its Lien on and continuing security interest in and to all of the right, title, and interest in, to and under the trademark registration that the Grantor assigned to Country Nation LLC and which is set forth in Schedule I, attached hereto and incorporated herein by this reference (the "Released Collateral"); and

WHEREAS, the security interest in the remaining Applicable Collateral granted to the Collateral Agent pursuant to the Trademark Security Agreement (the "Remaining Collateral"), will be unaffected by this Release and such Lien on and security interest in the Remaining Collateral will continue in full force and effect.

NOW, THEREFORE, for and in consideration of the foregoing, and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, and upon the terms set forth in this Release, the Collateral Agent, hereby TERMINATES, without recourse, representation, or warranty of any kind or nature the security interest in the Released Collateral, RELEASES and forever discharges, without recourse, representation, or warranty of any kind or nature its security interest in the Released Collateral, and retransfers and reassigns to Grantor any right, title or interest the Collateral Agent may have in, to or under the Released Collateral, without representation or warranty. The Collateral Agent shall retain its security interest in all other portions of the Trademark Collateral that are not the Released Collateral that is the subject of this Release.
