**RELEASE OF INTELLECTUAL PROPERTY SECURITY AGREEMENT**

October 15, 2019

WHEREAS, pursuant to that certain Intellectual Property Security Agreement, dated as of May 17, 2017, that was recorded May 17, 2017, at the United States Patent and Trademark Office on Reel: 6061; Frame: 0802 (the "Intellectual Property Security Agreement"), Connexin Software, Inc. ("Grantor"), pledged and granted to Western Alliance Bank (the "Secured Party"), to secure certain obligations, a lien on and security interest on certain of its assets, including the trademarks listed on Schedule I attached hereto (collectively, the "Trademark Collateral"); and

The Secured Party hereby, without any representation and warranty and without any recourse (a) terminates the liens and security interests created under the Intellectual Property Security Agreement in the Trademark Collateral, (b) releases its security interest in the Trademark Collateral, and (c) discharges any and all rights, title and interest it has in and the security interest granted to the Secured Party in the Trademark Collateral.

The Secured Party hereby authorizes Grantor and its agents, representatives and designees to record this Release of Intellectual Property Security Agreement with the United States Patent and Trademark Office.
