Ladies and Gentlemen:

Reference is made to that certain Intellectual Property Security Agreement, dated June 21, 2019 (as amended, the "Agreement"), by and between Crossroads Financing, LLC, a Connecticut limited liability company ("Secured Party") and RT Brands, LLC, a Delaware limited liability company ("RT Brands" or "Grantor"). Capitalized terms used and not identified herein shall have the meanings ascribed to them in the Agreement.

Pursuant to the Agreement, Grantor granted to Secured Party a security interest in and lien upon the Intellectual Property Collateral, including, without limitation, the Trademarks listed on Exhibit C to the Agreement. In addition, pursuant to Section 4(b) of the Agreement, Grantor granted to Secured Party a power of attorney to modify the Agreement by amending Exhibit C thereof to include reference to any right, title or interest in any Trademarks acquired by Grantor after the execution of the Agreement.

Following the execution and delivery by Grantor of the Agreement, Grantor registered with the United States Patent and Trademark Office, on October 10, 2019, certain trademarks as more fully set forth on Exhibit A attached hereto (the "Additional Marks").




