"1. The name of the Corporation is Greenfield Global USA Inc."

The amendment, and this Certificate of Amendment, shall be effective on August 3, 2017 at 9:00 a.m. EDT.

The corporation elects to be a Benefit Corporation. In addition to the stated purposes for which the corporation is formed, the corporation shall also have the purpose to create a general public benefit as defined in the Connecticut Benefit Corporation Act. 4. VOTE INFORMATION (SELECT A, B, C OR D):

A. THE AMENDMENT WAS APPROVED BY SHAREHOLDERS IN THE MANNER REQUIRED BY SECTIONS 33-600 TO 33-998 OF THE CONNECTICUT GENERAL STATUTES, AND BY THE CERTIFICATE OF INCORPORATION.
