ASSIGNMENT BY DEED

THIS ASSIGNMENT BY DEED ("Assignment") is dated

December 20th, 2018.

BETWEEN

- (1) **PAYSAFE HOLDINGS UK LIMITED**, a company incorporated in England and Wales with registered number 03202517 whose registered office is at Floor 27, 25 Canada Square, London, England, E14 5LQ (the "**Assignor**"), and
- (2) **SKRILL LIMITED**, a company incorporated in England and Wales with registered number 04260907 whose registered office is at 25 Canada Square, London, England, E14 5LQ (the "**Assignee**")

together the **Parties**, and each a **Party**.

BACKGROUND

The Assignor desires to assign certain assets and intellectual property rights to the Assignee on the terms set out below.

IT IS AGREED:-

1. Interpretation

1.1 The definitions and rules of interpretation in this clause apply in this Assignment:-

1.1.1 **API:** means an application programming interface;

1.1.2 **Assets:** the Neteiler Technology;

1.1.3 **Consideration:** means the amount of Euro 321,968,044;

1.1.4 **Effective Date:** means 1 January 2018;

1.1.5 **Features:** shall include the following features transaction limits, automated know-your-client processes, personal validation questions/challenges, account access and alternative payment provider integrations;

1.1.6 **Intangible Assets:** means the Neteiler Technology IPRs and the Paysafe Trade Marks;

1.1.7 **Intellectual Property Rights or IPRs:** means patents, rights to inventions, copyright and related rights, unregistered trade marks that are not applied to be registered as a trade mark, rights in get-up, rights in goodwill or to sue for passing off, unfair competition rights, rights in designs, rights in computer software, database rights, rights in confidential information (including know-how and trade secrets) and, save as set out herein, in each case whether registered or unregistered and including all applications (and rights to apply) for, and renewals or extensions of, such rights and all similar or equivalent rights or forms of protection which subsist or will subsist, now or in the future, in any part of the world. Notwithstanding the aforementioned, domain names, registered trade marks, and applications for registered trade marks and domain names shall be expressly excluded from this definition;

- 1.1.8 **Loan Agreement:** means the agreement to be entered into on the date of signing of this Assignment evidencing the Assignee's indebtedness to the Assignor in respect of the Consideration.
- 1.1.9 **Neteller Technology:** means the technology that is at the Effective Date, or has in the past been, comprised within the Neteller digital wallet platform and shall include everything comprised within the 'Neteller stack', namely the member portal for clients, merchants application for merchants, back office tools including internal management functions to service customers and memberships and 'Net +' card management (including prepaid cards), API application for merchant's integration for web services, internal operational application used for managing batch runs, enterprise services layer including more than 225 services such as manipulation and reporting of transaction data and authorization and encryption capabilities services, content management being the key commercial tool for functions such as marketing, and risk and fraud capabilities which leverage off the actimise system involving setting parameters, integration and know-how to ensure high performance against fraud; along with all Features, applications, software, code, executables, algorithms, parameters, concepts, tools, models, prototypes, methods, documentation, examples, materials, works, systems or otherwise comprised therein or related directly thereto;
- 1.1.10 **Neteller Technology IPRs:** the IPRs in the Neteller Technology; and
- 1.1.11 **Paysafe Trade Marks:** means the complete list of trade marks set out at schedule 1.
- 1.2 Clause and schedule headings shall not affect the interpretation of this Assignment.
- 1.3 A person includes a natural person, partnership, unincorporated association, body corporate, government, state or agency of a state, local or municipal authority or government body or a joint venture wherever incorporated or situated (in each case whether or not having separate legal personality) and includes that person's legal personal representatives, successors and permitted assigns.
- 1.4 A company includes any company, corporation or other body corporate, wherever and however incorporated or established.
- 1.5 Unless expressly provided otherwise in this Assignment, a reference to a statute, statutory provision or subordinate legislation is a reference to it as it is in force from time to time, taking account of:
- 1.5.1 any subordinate legislation from time to time made under it; and
- 1.5.2 any amendment or re-enactment and includes any statute, statutory provision or subordinate legislation which it amends or re-enacts.
- 1.6 The schedules form part of this Assignment and shall have effect as if set out in full in the body of this Assignment. Any reference to this Assignment includes the schedules.
- 1.7 References to clauses and schedules are to the clauses and schedules of this Assignment.

- 1.8 Words in the singular shall include the plural and vice versa. A reference to one gender shall include the other gender and neuter and vice versa.
- 1.9 Any reference to an English legal term for any action, remedy, method of judicial proceeding, legal document, legal status or legal concept is, in respect of any jurisdiction other than England and Wales, deemed to include what most nearly approximates in that jurisdiction to the English legal term.
- 1.10 Any reference to writing or written includes the representation or reproduction of words, symbols or other information in a visible form by any method or combination of methods, whether sent or supplied in electronic form or otherwise.
- 1.11 Any obligation in this Assignment on a person not to do something includes an obligation not to agree or allow that thing to be done.
- 1.12 Any phrase introduced by the terms including, include, in particular or any similar expression shall be construed as illustrative and shall not limit the sense of the words preceding those terms.

2. Effective Date

- 2.1 This Assignment shall be legally effective on the Effective Date.

3. Assignment

- 3.1 The Assignor irrevocably **HEREBY ASSIGNS, CONVEYS AND TRANSFERS BY DEED** to the Assignee, its successors, assigns and legal representatives, with full title guarantee and without restriction all legal and beneficial right, title and interest past, present and future absolutely in the Assets and the Intangible Assets (under any and all laws and in any and all jurisdictions) together with all rights of action powers and benefits accruing or belonging to the owners of the Assets and the Intangible Assets including without limitation:-

- 3.1.1 the right to sue for damages and seek other legal remedies in respect of all causes of action relating to the Assets and the Intangible Assets arising prior to, on, or after, the Effective Date, including without limitation the right to obtain equitable relief, including injunctive relief, and the right to fully and entirely stand in the place of the Assignor in all matters relating to the Assets and the Intangible Assets;
- 3.1.2 the right to register and/or apply for, and claim priority from, and/or prosecute and/or maintain, patents, utility models, design registrations and the like rights of exclusion with respect to the Assets and the Intangible Assets in all countries and/or territories in the world;
- 3.1.3 the absolute entitlement to any registrations granted pursuant to any applications to register the Intangible Assets; and
- 3.1.4 the right for the Assignee, its successors, assigns and legal representatives to use and enjoy the Assets and the Intangible Assets as fully and entirely as would have been held and enjoyed by the Assignor had this Assignment not been entered into.

4. Consideration

4.1 The Consideration shall remain outstanding at the date of signing of this Assignment on an inter-company loan account and shall constitute an interest-accruing unsecured debt of the Assignee payable to the Assignor in accordance with the terms of the Loan Agreement.

5. Warranties

5.1 The Assignor warrants that:-

5.1.1 it is at the Effective Date the legal and beneficial owner of all legal and beneficial right, title and interest in and to the Assets and the Intangible Assets;

5.1.2 it has not at the Effective Date licensed or assigned, or purported to license or assign the Assets or the Intangible Assets or any part therein to any third party, and shall not in the future purport to do so;

5.1.3 it has procured all waivers from all authors of the Assets in relation to any moral rights that such authors may have in connection thereto arising under the Copyright, Designs and Patents Act 1988 and, as far as is legally possible, waivers or consents in relation to any broadly equivalent rights such authors may have in any country and/or territory of the world; and

5.1.4 the Assets and the Intangible Assets are free from any security interest, option, mortgage, charge or lien.

5.2 Each Party acknowledges that, in entering into this Assignment, it has not relied on any warranty, representation or undertaking except those expressly set out in this Assignment and each Party waives any claim for breach of any representation (unless made fraudulently) which is not specifically contained in this Assignment as a warranty.

6. Further Assurances

6.1 The Assignor shall at the request of the Assignee, do all acts and things (including, without limitation, executing all documents necessary and/or desirable and providing all necessary assistance) to give full effect to the terms herein, including but not limited to (i) securing the vesting in Assignee of all right, title and interest in the Intangible Assets, (ii) recording the assignment of each trade mark comprised within the Paysafe Trade Marks in the relevant trade mark registries in such form as the Assignee shall request, including entering into a confirmatory assignment for such purposes (iii) delivering up the Assets in whatever format or medium to the Assignee on request, (iv) providing all such assistance as the Assignee may require in the event that any person or entity bring a claim against the Assignee alleging that the reproduction, use or exploitation of any Asset (or part therein) infringes the rights of any third party, and (v) entering into novation(s) to give the Assignee and their successors, assigns and legal representatives the full benefit of clause **Error! Reference source not found.**

7. Power of Attorney

7.1 The Assignor hereby appoints the Assignee to be its attorney in order to execute, do all such acts and deeds, and execute all such further documents and instruments as the Assignee may in its absolute discretion deem necessary

or desirable in order to give full effect to the Assignment and the Assignor hereby agrees, ratifies and confirms all such further acts, deeds, documents and instruments which the Assignee may do or execute pursuant to such appointment.

8. Previous Names for Assignor

8.1 The Assignor was incorporated on 22 May 1996 as GLOBAL NETSITE SOLUTIONS LIMITED. A copy of the certificate of incorporation is at **schedule 2**. On 11 July 1997 the company changed its name to NETINVEST LIMITED, which was further changed on 7 February 2017 to PAYSAFE HOLDINGS UK LIMITED. A copy of these certificates of change are also set out at **schedule 2**.

9. General

9.1 Either party may at any time assign any or all of its rights under this Assignment.

9.2 Either Party may at any time and without notice to the other Party set off any liability of it to the other Party against any liability of the other Party to it, whether either liability is present or future, liquidated or unliquidated, and whether or not either liability arises under this agreement or another agreement. Any exercise by either Party of its rights under this clause shall not limit or affect any other rights or remedies available to it under this Assignment or otherwise. In case of an assignment, the assignee could exercise any and all of the set off rights.

9.3 Any failure or delay of any party to exercise any rights or powers (or part thereof) under this Assignment shall not be deemed to be a waiver of those or any other rights, unless expressly so agreed in writing by such Party.

9.4 Should any provision of this Assignment be declared void or otherwise unenforceable, then the Parties shall consult with each other and agree an alternative provision which achieves a result as similar as possible to the results which would have been achieved by the unenforceable provision provided always that if this remedying mechanism is not permitted by law then such provision shall be severed and the remainder of the provisions in this Assignment shall continue in full force and effect as if this Assignment has been executed with the invalid, illegal or unenforceable provision eliminated.

9.5 This Assignment constitutes the entire agreement and understanding between the Parties with regard to its subject matter and supersedes all prior oral or written agreements, representations, understandings or arrangements between the Parties relating to its subject matter. Any amendment to this Assignment must be made in writing and signed by the duly authorised representatives of each Party.



9.7 This Assignment and any non-contractual obligations arising out of or in connection with it or its subject matter shall be governed by and construed in


accordance with English law and the Parties hereby submit to the exclusive jurisdiction of the English courts to settle any dispute or claim arising out of or in connection with this Assignment or its subject matter or formation.
