**TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARK
COLLATERAL**

This TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARK COLLATERAL (this “Release”) is made as of September 20, 2019 (“Effective Date”), by OBSIDIAN AGENCY SERVICES, INC., a California corporation (“Obsidian”), in its capacity as collateral agent for the Lenders, as such term is defined in the below defined Credit Agreement (together with its successors in such capacity, “Grantee”), in favor of Acronis International GMBH (the “Borrower”), GroupLogic, Inc. (“GroupLogic”), Acronis, Inc. (“Acronis”) and any other entities from time to time party to the below defined Trademark Security Agreements (together with the Borrower, GroupLogic and Acronis, each a “Grantor”, and collectively, the “Grantors”).

WHEREAS, reference is made to (a) that certain Guarantee and Collateral Agreement dated as of February 21, 2014 (as amended, restated, amended and restated, supplemented or otherwise modified from time to time, the “Security Agreement”) among Acronis AG (“Holdings”), the Grantors, each other entity from time to time party thereto and the Collateral Agent, and (b) that certain Credit Agreement, dated as of June 6, 2014 (as amended, restated, amended and restated, supplemented or otherwise modified from time to time, the “Credit Agreement”), by and among the Borrower, Holdings, the lenders from time to time party thereto (the “Lenders”) and Obsidian Agency Services, Inc., as administrative agent and collateral agent;

WHEREAS, pursuant to the terms and conditions of that certain (a) Trademark Security Agreement, dated as of February 21, 2014 (as amended, restated, amended and restated, supplemented, or otherwise modified from time to time, the “Original Trademark Security Agreement”), by and among Grantors and Grantee, the Grantors granted to Grantee a security interest in all of Grantors’ right, title and interest in and to the Collateral (as such term is defined in the Original Trademark Security Agreement) and (b) Supplemental Trademark Security Agreement, dated as of July 21, 2017 (as amended, restated, amended and restated, supplemented, or otherwise modified from time to time, the “Supplemental Trademark Security Agreement” and together with the Original Trademark Security Agreement, collectively the “Trademark Security Agreements”) by and among Grantors and Grantee, Grantors granted to Grantee a security interest in all of Grantors’ right, title and interest in and to the Collateral (as such term is defined in the Supplemental Trademark Security Agreement); and

WHEREAS, (a) the Original Trademark Security Agreement was recorded with the Trademark Division of the United States Patent and Trademark Office on February 27, 2014 at Reel 5226, Frame 0286 and (b) the Supplemental Trademark Security Agreement was recorded with the Trademark Division of the United States Patent and Trademark Office on July 26, 2017 at Reel 6115, Frame 0563; and

WHEREAS, Grantee now desires to release its security interest in the Collateral (as defined in each Trademark Security Agreement), including, without limitation, the trademarks, trademark applications and trademark licenses recorded at the United States Patent and Trademark Office and listed on Schedule A hereto.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Grantee hereby covenants and agrees as follows:

1. Defined Terms. Unless otherwise specified herein, all capitalized terms used but not defined herein have the meanings given to them in the Security Agreement, Credit Agreement or the Trademark Security Agreements, as appropriate.

2. Release of Grant of Security Interest. Without representation or warranty of any kind or nature, Grantee, on behalf of itself and the Lenders, hereby (i) terminates each Trademark Security Agreement and (ii) terminates, releases, and discharges all of its security interest and the Lenders' security interest in all of Grantors' right, title and interest in and to the Collateral granted pursuant to the Trademark Security Agreements, and reassigns to Grantors all right, title, and interest of Grantee and of the Lenders in the Collateral.

3. Recordation. Grantee authorizes and requests that the Commissioner for Trademarks and any other applicable government officer or relevant governmental authority record this Release.


4. Further Assurances. Grantee hereby agrees to duly execute, acknowledge, procure and deliver any further documents and to do such other acts, in each case at Grantors' expense, as may be reasonably necessary to effect the release of the security interest in the Collateral contemplated hereby.

5. Governing Law. This Release shall be construed in accordance with and governed by the laws of the State of New York.
