## IP ASSIGNMENT AGREEMENT

This IP ASSIGNMENT AGREEMENT ("Assignment"), dated as of June 4, 2019, is entered into by BRE/BATON OPERATING LESSEE LLC, a Delaware limited liability company ("Operating Lessee"), PANTHERS BRHC L.L.C. and BRE/JEWEL PARCEL L.L.C., each a Delaware limited liability company (collectively, "Seller" and, together with Operating Lessee, individually or collectively as the context requires, "Assignor") in favor of BOCA OWNER, LLC, a Delaware limited liability company ("Boca Owner"), BOCA BUNGALOWS OWNER, LLC, a Delaware limited liability company ("Bungalows Owner"), BOCA PREMIER CLUB OWNER, LLC, a Delaware limited liability company ("Premier Club Owner"), BOCA JEWEL PARCEL OWNER, LLC, a Delaware limited liability company ("Jewel Parcel Owner"), and BOCA COUNTRY CLUB OWNER, LLC, a Delaware limited liability company ("Country Club Owner" and, together with Boca Owner, Bungalows Owner, Premier Club Owner and Jewel Parcel Owner, "Assignee"; Assignee and Assignor are collectively referred to herein as the "Parties").

WHEREAS, Seller (as seller) and Boca Owner (as buyer) have entered into that certain Agreement of Purchase and Sale, dated as of April 18, 2019 (as the same may be amended, modified and/or supplemented from time to time, the "Purchase Agreement"). Defined terms used herein but not otherwise defined shall have the meanings assigned to such terms in the Purchase Agreement; and

WHEREAS, pursuant to the Purchase Agreement, Seller has agreed to assign, and to cause Operating Lessee to assign, to Assignee all of Assignor's right, title and interest in and to the Asset-Related Property, including the Transferred IP (defined below).

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the Parties hereby agree as follows:

SECTION 1. Assignment. Assignor hereby sells, conveys, assigns and transfers to Assignee all of Assignor's right title and interest in and to, subject to the terms and conditions of the Existing Management Agreement, all intellectual property owned by the Assignor and exclusively related to the Property, including, without limitation, all such trademarks, service marks, copyrights, domain names and social media identifiers, and all associated goodwill, including all registered and applied for intellectual property, as specifically set forth on Schedules 1 through 5 hereto (the "Transferred IP").

SECTION 2. Representations and Warranties. This Assignment is made without warranty or representation, express or implied, by or recourse against Assignor of any kind or nature whatsoever except as set forth in the Purchase Agreement.

SECTION 3. Successors and Assigns. This Assignment shall be binding upon, and inure to the benefit of, Assignor and Assignee and their respective successors and assigns.

SECTION 4. Governing Law. This Assignment shall be governed by, interpreted under, and construed and enforceable in accordance with, the laws of the State of New York.


SECTION 5. Recordation. This Assignment has been executed and delivered by the Assignor for the purpose of recording the assignment herein with the United States Patent and Trademark Office and the United States Copyright Office.

SECTION 6. Counterparts. This Assignment may be executed in any number of counterparts and by facsimile or PDF signatures delivered via email, each of which shall be deemed an original, and all of which, together, shall constitute one and the same instrument.
