**TERMINATION AND RELEASE OF
FIRST SUPPLEMENT TO TRADEMARK SECURITY AGREEMENT**

This **TERMINATION AND RELEASE OF FIRST SUPPLEMENT TO TRADEMARK SECURITY AGREEMENT** (this “*Termination and Release*”) is granted as of October 22, 2019 by **SILICON VALLEY BANK**, as Administrative Agent (the “*Assignee*”), in favor of **INFINSOURCE, INC.**, a Michigan corporation (“*Infinisource*”), **STONE MOUNTAIN BENEFITS, LLC**, a Delaware limited liability company (“*Stone*”), and **JOBMATCH LLC**, an Utah limited liability company (“*Jobmatch*” together with *Infinisource*, and *Stone*, are individually, a “*Grantor*”, and collectively, the “*Grantors*”).

WHEREAS, the Grantors executed and delivered a First Supplement to Trademark Security Agreement dated as of June 13, 2017 that amended that certain Trademark Security Agreement, dated as of August 8, 2011 (as amended, restated, supplemented or otherwise modified prior to the date hereof, the “*Grant*”) granting the Assignee a security interest in and lien on certain trademarks and trademark applications (“*Trademarks*”) described therein, which was recorded with the United States Patent and Trademark Office (“*USPTO*”) on June 13, 2017, at Reel 6083, Frame 0238;

WHEREAS, Grantors have requested that Assignee hereby terminate, release and discharge fully its security interests in and liens on all right, title and interest of Grantors in, to and under all of the Trademarks as herein provided; and

WHEREAS, Grantors have requested that the Assignee provide a document suitable for recording with the USPTO to evidence the release of the Assignee’s security interests in and liens on the certain Trademarks as herein provided.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Assignee hereby:

1. terminates the Grant and releases, terminates and discharges all liens and security interests in each Grantor’s right, title and interest in, to and under the Trademarks, and all goodwill associated therewith, including those certain Trademarks identified in Schedule I hereto; and
2. authorizes and requests that this Termination and Release be recorded at the USPTO.

THIS TERMINATION AND RELEASE AND THE RIGHTS AND OBLIGATIONS OF THE PARTIES HEREUNDER SHALL BE GOVERNED BY, AND SHALL BE CONSTRUED AND INTERPRETED IN ACCORDANCE WITH, THE LAWS OF THE STATE OF NEW YORK.
