WHEREAS, ASSIGNOR did assign to ASSIGNEES, as of the effective date of this Assignment, all rights, title, and interest as ASSIGNOR did possess in and to the Trademark and Registration, together with the goodwill and business associated therewith.

NOW, THEREFORE, for good and adequate consideration, the receipt and sufficiency of which is hereby acknowledged, ASSIGNOR hereby acknowledges and confirm the assignment and sale to ASSIGNEES all rights, title, and interest as ASSIGNOR did possess in and to the following:

- (2) the Registrations set forth in Schedule B

together with the goodwill symbolized by said Trademark and Registration, concurrent with the transfer of certain tangible assets as indicia of said goodwill.
