**TERMINATION AND RELEASE  
OF SECURITY INTEREST IN TRADEMARKS**

This TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS (the "Release") is executed as of October 18, 2019, by Royal Bank of Canada, in its capacity as collateral agent for the Secured Parties (in such capacity, together with its successors and permitted assigns, the "Collateral Agent") in favor of Infoblox Inc., a Delaware corporation, and DIGITAL FOOTPRINTS INTERNATIONAL, L.L.C., a Washington limited liability company (collectively, the "Pledgors" and each, individually, a "Pledgor").

WHEREAS, reference is made to that certain Second Lien Security Agreement, dated as of November 7, 2016 (as amended, restated, amended and restated, supplemented or otherwise modified from time to time, the "Security Agreement");

WHEREAS, the Pledgors and the Collateral Agent executed a certain Second Lien Trademark Security Agreement, dated as of November 7, 2016 (as amended, restated, supplemented or otherwise modified from time to time, the "Trademark Security Agreement"), pursuant to which each Pledgor granted to the Collateral Agent a continuing security interest (the "Security Interest") in all of such Pledgor's right, title and interest in, to and under the Trademark Collateral (as defined in the Trademark Security Agreement), including the Trademarks listed on Exhibit A hereto;

WHEREAS, the Trademark Security Agreement was recorded with the United States Patent and Trademark Office ("USPTO") on November 8, 2016 at (i) Reel 5917 and Frame 0807 and (ii) Reel 5917 and Frame 0815; and

WHEREAS, the Collateral Agent has agreed to terminate and release its Security Interest in the Trademark Collateral, including the Trademarks listed on Exhibit A hereto.

NOW, THEREFORE, for good and valuable consideration, the receipt and adequacy of which the parties acknowledge, the Collateral Agent hereby releases, terminates and discharges the Trademark Security Agreement and the Security Interest granted under the Trademark Security Agreement in the Trademark Collateral, including the Trademarks listed on Exhibit A hereto, and any right, title or interest of the Collateral Agent in such Security Interest shall hereby terminate, cease and become void. The Collateral Agent hereby consents to the recording of this Release with the USPTO.
