ASSIGNMENT OF TRADEMARK

WHEREAS, GUNNTECH MANUFACTURING, INC. (“**Gunntech**”), a corporation of the State of Idaho, is the owner of the registered trademark application for Bullet Tools, U.S. Trademark Application Serial No. 88/407,717 for the mark that consists of a standard characters without any particular font style, size or color depicting the words BULLET TOOLS.

WHEREAS, MARSHALLTOWN COMPANY (“**Marshalltown**”), a corporation of the State of Iowa, is desirous of acquiring the entire right, title and interest in and to such trademark registration and application, including any common law trademark rights related to the mark.

WHEREAS, Gunntech and Marshalltown have entered into an Asset Purchase Agreement dated as of September 19, 2019 (“**Agreement**”) pursuant to which Gunntech has agreed to sell, assign, transfer, convey and deliver to Marshalltown and Marshalltown has agreed to purchase and acquire from Gunntech, all right, title and interest to certain assets.

WHEREAS, in accordance with the Agreement, Gunntech and Marshalltown are desirous of transferring all right, title and interest in the trademark referenced herein, together with the goodwill associated therewith from Gunntech to Marshalltown.

NOW, THEREFORE, in consideration of entering into Agreement and for other good and valuable consideration, the receipt of which is hereby acknowledged, Gunntech, does hereby assign, sell and convey to Marshalltown, the trademark application and all rights in the current or pending mark that consists of standard characters without any particular font style, size or color depicting the words BULLET TOOLS, together with the goodwill associated therewith, and including the right to sue for past infringement if any there may be. Gunntech covenants that it will at any time hereafter, at Marshalltown’s request, execute and deliver all other instruments

necessary, in the opinion of Marshalltown's counsel, to complete or perfect the pending application of or transfer of title to the trademark application and registration to Marshalltown.
