PAYOUT, RELEASE AND AUTHORIZATION TO DISCHARGE

To: AudienceView Ticketing Corporation ("AVTC")
And To: AudienceView Ticketing (USA) Corporation ("AVUSA")
And To: AudienceView Ticketing (UK) Limited ("AVUK")
And To: Cognition LLP
And To: Aird & Berlis LLP
And To: Silicon Valley Bank

Re: Third Amended and Restated Loan Agreement dated as of June 29, 2012 between AVTC and Comerica Bank (as amended from time to time, the "Loan Agreement").

Comerica Bank ("Comerica") hereby confirms that on the date hereof, the amount required to pay out all credit facilities established by Comerica in favour of AVTC is the sum of \$0 (such amount, together with per diem interest, from and after the date hereof, in the amount of \$0 and legal fees in the amount of \$700 plus applicable tax is collectively referred to as the "Debt"). Payment of the Debt has been made by wire transfer on or prior to May 1, 2015 to Comerica Bank.

Upon payment and receipt by Comerica of the Debt, all credit facilities established by Comerica in favour of AVTC, AVUSA and AVUK will be paid out and terminated (except for the indemnification obligations of AVTC with respect to those expenses, damages, losses, costs and liabilities that, pursuant to the Loan Agreement, are expressly stated to survive until all applicable statute of limitations periods with respect to actions that may be brought against Comerica have run), and, accordingly, each of Cognition LLP and Aird & Berlis LLP are immediately authorized to thereafter discharge at AVTC's expense the financing statements and security agreements filed or recorded by or on behalf of Comerica against AVTC, AVUSA and AVUK in respect of the Debt, including the financing statements and security agreements described in Schedule "A" attached hereto.

In addition, Comerica hereby agrees to execute and deliver, as reasonably requested by AVTC, AVUSA or AVUK, at AVTC's expense, any and all other lien releases, discharges of security interests, financing change statements, UCC financing statements and other similar discharge or release documents as are necessary or desirable to release any other security interests, financing statements and liens previously filed or recorded by or on behalf of Comerica, and to return to AVTC, AVUSA and AVUK any items or property held as collateral for the Debt.
