**TERMINATION AND RELEASE
OF
AMENDED AND RESTATED
INTELLECTUAL PROPERTY SECURITY AGREEMENT**

October 21, 2019

WHEREAS, OWNERIQ, INC., a Delaware corporation (“Grantor”), and PACIFIC WESTERN BANK (“Bank”) entered into a Supplement to Amended and Restated Intellectual Property Security Agreement, dated as of July 19, 2019 (the “Supplement”), amending the Amended and Restated Security Agreement, dated as of April 17, 2018 (the “Security Agreement”; capitalized terms used herein but not defined are used as defined in the Security Agreement), which Supplement was recorded with the United States Patent and Trademark Office on July 22, 2019, at Reel 006699, Frame 0322, for the purpose of collateral security for all indebtedness and obligations of the Grantor to Bank arising under a certain Loan Agreement (as defined in the Security Agreement, and together with the Security Agreement and the Supplement, the “Loan Documents”);

WHEREAS, pursuant to the Loan Documents, the Grantor pledged and assigned to Bank, and granted Bank a security interest in its Intellectual Property, including without limitation the Copyrights, Patents and Trademarks listed on Schedule A hereto (collectively, the “Intellectual Property”); and

WHEREAS, Bank has agreed to terminate and release its security interest in the Intellectual Property as herein provided.

NOW, THEREFORE, for valuable consideration Bank hereby terminates and releases its security interest in the Intellectual Property, including without limitation the Copyrights, Patents and Trademarks listed on Schedule A hereto, and Bank hereby assigns and transfers to the Grantor, without representation, warranty or recourse, all of Bank’s right, title and interest in and to such Intellectual Property, effective as of the date set forth above.
