**TERMINATION AND RELEASE OF SECURITY INTEREST
IN TRADEMARKS**

This **TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS**, dated as of October 25, 2019 (this “Release”), is made by SunTrust Bank, as Administrative Agent (the “Administrative Agent”) in favor of OWS, LLC, a Delaware limited liability company (the “Obligor”).

WHEREAS, pursuant to that certain Amended and Restated Security and Pledge Agreement dated as of August 1, 2017 (as amended, modified, supplemented, increased, extended, restated, refinanced and replaced from time to time, the “Security Agreement”) by and among the Obligor, the Administrative Agent and others party thereto, the Obligor granted to the Administrative Agent, for the benefit of the holders of the Secured Obligations, a continuing security interest in, and a right to set off against, any and all right, title and interest of the Obligor in and to all Trademarks, Trademark Licenses, and Proceeds of the foregoing (collectively, the “Trademark Collateral”); and

WHEREAS, pursuant to the Security Agreement, the Obligor executed and delivered to the Administrative Agent, for the benefit of the holders of the Secured Obligations, the Notice of Grant of Security Interest in Trademarks recorded at the United States Patent and Trademark Office (the “USPTO”) on June 23, 2016 at Reel 5820 Frame 0787 (the “Notice”).

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Administrative Agent, on behalf of the holders of the Secured Obligations, and the Obligor agree as follows:

SECTION 1. Defined Terms. All capitalized terms used herein but not otherwise defined herein have the meanings given to them in the Security Agreement.

SECTION 2. Termination and Release. Administrative Agent, on behalf of the holders of the Secured Obligations, without representation, warranty, or recourse, hereby:

- (a) terminates, cancels, discharges, and releases the continuing security interest in, and the right to set off against, the Obligor’s right, title, and interest in and to all the Trademark Collateral, including, but not limited to, the foregoing listed on Schedule A attached hereto, granted pursuant to the Security Agreement or the Notice; and
- (b) authorizes the recordation of this Release with the USPTO at the Obligor’s expense.

SECTION 3. Choice of Law. This Release shall be governed by and construed in accordance with the laws of the State of New York.
