## INTELLECTUAL PROPERTY ASSIGNMENT

This Intellectual Property Assignment (the "Assignment") is made and entered into as of October 17, 2019 (the "Effective Date"), by and between Dental One, Inc., a Delaware corporation, and DentalOne Partners, Inc., a Delaware corporation (collectively "Assignor"), and (ii) DCP Equity Partners, LLC, a Delaware limited liability company ("Assignee"), as part of a reorganization. Assignor and Assignee shall each be referred to herein as a "Party" and, collectively, the "Parties".

### RECITALS

**A.** Assignor is the owner of certain trademarks, service marks, trade dress, logos, slogans, trade names, domain names, URLs, brand names, and corporate names, user names, screen names, internet and mobile account names (including social media names, "tags," and "handles") or other designations of source, origin, sponsorship, endorsement or certification, together with all goodwill associated with any of the foregoing, whether or not applied for or registered and all applications, registrations and renewals in connection therewith, including but not limited to the trademarks set forth on Schedule A hereto (collectively referred to as the "Marks");

**B.** Assignor is also the owner of certain Copyrights, and certain Trade Secrets (collectively, the "Marks," "Copyrights," and "Trade Secrets" set forth on Schedule A are the "Intellectual Property");

**C.** Assignor desires to assign all of its right, title and interest in and to the Intellectual Property to Assignee, and Assignee desires to acquire the Intellectual Property.

### AGREEMENT

For the good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Assignor and Assignee hereby agree as follows:

**1. Defined Terms.** Capitalized terms used but not otherwise defined in this Assignment shall have the meanings given to them in that certain Equity Purchase Agreement, dated as of October 4, 2019 (as such may be amended, the "Purchase Agreement"), by and among Mid-Atlantic Intermediate, LLC, a Delaware limited liability company, Mid-Atlantic Holdco, LLC, Assignor and certain other parties thereto.

**2. Assignment.** Assignor hereby sells, assigns, transfers, conveys and delivers to Assignee all right, title and interest, in and to the Intellectual Property, free and clear of all Liens (except Goldman Liens), in all countries throughout the world, for Assignee's own use and enjoyment, and for the use and enjoyment of Assignee's successors, assigns or other legal representatives, as fully and entirely as the same would have been held and enjoyed by Assignor if this Assignment had not been made, including but not limited to:

- (a) All Marks;
- (b) All Copyrights;
- (c) All Trade Secrets
- (d) The right to reproduce, sell copies of, display, reproduce and create derivative works based on the Copyrights;

(e) All causes of action, damages and remedies for any and all past, present or future infringement of the rights in the Intellectual Property being assigned, and the right to receive and retain the proceeds relating to those infringements;

(f) The right to assign or license the Intellectual Property; and

(g) All incomes, proceeds, royalties, license fees, and other payments now or hereafter derived from exploitation of the Intellectual Property.

**3. Representations and Warranties of Assignor.** Assignor hereby represents and warrants to Assignee that:

(a) Organization. Assignor is a corporation duly incorporated, validly existing and in good standing under the laws of the State of Delaware and has fully corporate power and authority to carry on its business as currently conducted and to own and lease the rights, properties and assets that it currently owns or leases.

(b) Authority and Validity. This Assignment has been duly authorized, executed and delivered by Assignor, and does not require any further authorization or consent, and is its legal, valid and binding obligation, enforceable against it in accordance with the terms hereof.

(c) No Conflicts. The execution, delivery and performance by Assignor of this Assignment, and the consummation by Assignor of the transactions contemplated hereby do not and will not: (i) require the consent of or notice to any Governmental Body; (ii) conflict with or result in a violation of any Law, Court Order or injunction of any court or Governmental Body to which Assignor is subject or bound; nor (iii) violate, conflict with, result in a Default under (with or without notice or lapse of time or both), require notice, filing, consent or other action under, or accelerate or permit the termination or acceleration of any performance required by the terms of any Contract, Charter Document or Governmental Permit to which Assignor is a party or by which Assignor is bound, nor result in the creation of any Liens upon any of the assets of Assignor.

**4. Representations and Warranties of Assignee.** Assignee hereby represents and warrants to Assignor that:

(a) Organization. Assignee is a limited liability company duly organized, validly existing and in good standing under the laws of the State of Delaware and has full limited liability company power and authority to carry on its business as currently conducted and to own and lease the rights, properties and assets that it currently owns or leases.

(b) Authority and Validity. This Assignment has been duly authorized, executed and delivered by Assignee, and does not require any further authorization or consent, and is its legal, valid and binding obligation, enforceable against it in accordance with the terms hereof.

(c) No Conflicts. The execution, delivery and performance by Assignee of this Assignment, and the consummation by Assignee of the transactions contemplated hereby do not and will not: (i) require the consent of or notice to any Governmental Body; (ii) conflict with or result in a violation of any Law, Court Order or injunction of any court or Governmental Body to which Assignee is subject or bound; nor (iii) violate, conflict with, result in a Default under (with or without notice or lapse of time or both), require notice, filing, consent or other action under, or accelerate or permit the termination or acceleration of any performance required by the terms of any Contract, Charter Document or Governmental Permit to which

Assignee is a party or by which Assignee is bound, nor result in the creation of any Liens upon any of the assets of Assignee.

5. **Recordation.** To the extent applicable, Assignor hereby requests the Commissioner for Trademarks at the United States Patent and Trademark Office (the "Commissioner"), the Register of Copyrights and Director of the U.S. Copyright Office (the "Director"), as well as his or her counterparts at the corresponding entities or agencies in any country or jurisdiction that may exercise authority over any of the Intellectual Property, to record this Assignment. Assignor hereby further requests the Commissioner, the Director, and his or her non-US counterparts to issue any and all trademark and copyright registrations resulting from applications among the Marks or Copyrights or derived therefrom to Assignee as assignee of the entire interest therein.

6. **Further Assurances.** Upon reasonable request by Assignee, and at Assignee's sole cost and expense, Assignor will execute further papers (including, without limitation, the execution and delivery of affidavits, declarations, oaths, samples, exhibits, specimens, assignments, powers of attorney or other documentation) and to do such other acts as may be necessary or reasonably requested by Assignee to vest full title in and to all Intellectual Property in Assignee or which may be necessary to obtain, renew, issue or enforce the Intellectual Property.






