TRADEMARK ASSIGNMENT AGREEMENT

THIS ASSIGNMENT is effective as of September 26, 2019 at 9:00 A.M. (the “**Effective Date**”), by and between **REVISION MILITARY INC.**, a corporation existing under the laws of Canada and having a principal place of business at 200-3800 Saint-Patrick Street, Montréal, Québec, H4E 1A4, Canada (the “**Assignor**”), and **REVISION MILITARY EYEWEAR (CANADA) INC.**, a corporation existing under the laws of Canada and having a principal place of business at 200-3800 Saint-Patrick Street, Montréal, Québec, H4E 1A4, Canada (the “**Assignee**”).

WHEREAS the Assignor is the owner of the entire rights, title and interest in and to the trademarks listed on Schedule “A” attached hereto, including any applications therefor or registrations thereof in Canada, and the United States, and all foreign countries (the “**Trademarks**”); and

WHEREAS pursuant to the Asset Transfer Agreement effective as of the date hereof between the Assignor and the Assignee (the “**Transfer Agreement**”), the Assignee has acquired all of the Assignor’s rights, title and interest in and to the Trademarks and the goodwill associated therewith; and

WHEREAS the Assignor and the Assignee desire to memorialize the transfer of the Trademarks from the Assignor to the Assignee.

NOW, THEREFORE, the Assignor declares as follows:

The preamble shall form an integral part hereof.

In consideration of the Transfer Agreement and other good and valuable consideration, the receipt of which is hereby acknowledged, the Assignor hereby confirms the sale, assignment and transfer to the Assignee of all of the Assignor’s rights, title and interest in and to the Trademarks and the goodwill connected with the use and as symbolized by the Trademarks, all common law and statutory rights related thereto, and all rights of renewal and extension if any relating thereto on a worldwide basis, as of the Effective Date. The Trademarks are being assigned as part of the portion of the Assignor’s business to which the Trademarks pertain.

The Assignor further confirms the transfer and assignment to the Assignee of the right to sue for past infringement, to institute or continue opposition and cancellation proceedings and other legal proceedings and to recover and retain all damages and profits arising in connection with such Trademarks.

The Assignor undertakes to, upon the written request of the Assignee, execute all papers, make all rightful oaths, testify on behalf of the Assignee, and do all other acts necessary to carry out the intent of this Agreement, as well as to provide such other material, information and/or assistance as the Assignee may consider necessary.

This Agreement has been executed and delivered pursuant to the Transfer Agreement but shall be deemed not to enlarge, diminish, modify, alter or supersede any of the representations, warranties, covenants or agreements set forth in the Transfer Agreement. The Transfer Agreement shall control in the case of any conflict or inconsistency between this Agreement and the Transfer Agreement.

This Agreement shall enure to the benefit of and be binding upon the parties, their successors, administrators, assigns, and all others acting by, through, with or under their direction and all those in privity therewith.

The parties hereby irrevocably and unconditionally attorn to the arbitration clause set out in Section 8.8 of the Transfer Agreement.

All matters relating to the interpretation, construction, validity and enforcement of this Agreement will be governed by and construed in accordance with the domestic laws of the State of Delaware without giving effect to any choice or conflict of law provision or rule (whether of the State of Delaware or any other jurisdiction) that would cause the application of laws of any jurisdiction other than the State of Delaware.
