**GRANT OF SECURITY INTEREST
IN UNITED STATES TRADEMARKS**

WHEREAS, the undersigned grantors (each a "Grantor" and collectively "Grantors") have adopted, used and is using the mark shown in the attached Schedule A (the "Mark"), for which there are registrations or applications in the United States Patent and Trademark Office under the number shown in the attached Schedule A; and

NOW, THEREFORE, for good and valuable consideration, receipt of which is hereby acknowledged, Grantors do hereby grant, which grant is and shall be deemed to be one and the same grant as the grant set forth in the Agreements, to Agent for its benefit and for the ratable benefit of the Secured Parties (as defined in the Loan Agreement) a security interest in and to Grantors' Mark, together with the goodwill of the business symbolized by such Mark, and registrations and applications therefor, which security interest shall secure all the Obligations as defined in the Agreements and in accordance with the terms and provisions thereof; provided that no security interest is granted hereunder in any of the items excluded from the definition of "Collateral" contained in the Loan Agreement as set forth in Section 2.7(A) of the Loan Agreement.


