TERMINATION OF SECURITY INTEREST IN TRADEMARKS

Irrevocably and unconditionally releases, terminates and reassigns to the Pledgors any and all liens, security interests, right, title and interest of Pledgee granted pursuant to the Trademark Security Agreement or otherwise, including all liens, security interests, right, title and interest of Pledgee in the Trademarks, without recourse or representation or warranty, express or implied; and
2. Authorizes and requests the Commissioner of Patents and Trademarks of the United States of America to note and record the existence of the termination and release hereby given.


