INTELLECTUAL PROPERTY ASSIGNMENT AGREEMENT

This **INTELLECTUAL PROPERTY ASSIGNMENT AGREEMENT** (this "Assignment Agreement") is made as of October 31, 2017 (the "Effective Date"), by and between **NUK USA LLC**, a Delaware limited liability company ("Assignor"), and **RUBBERMAID COMMERCIAL PRODUCTS LLC**, a Delaware limited liability company ("Assignee").

RECITALS

WHEREAS, as of the date first set forth above, Assignor desires to assign to Assignee, and Assignee desires to assume, any and all of Assignor's right and interest to, and obligations under (a) certain trademarks, trademark registrations, applications to register, and the goodwill of the business with which those certain trademarks are used and that is symbolized by such trademarks identified in *Exhibit A* attached hereto (the "Trademarks"), to the extent that such rights and goodwill exist; and

WHEREAS, Assignor and Assignee wish to execute and deliver this Assignment Agreement to effectuate such assignment and assumption.

AGREEMENT

NOW, THEREFORE, in consideration of the foregoing recitals and of other good and valuable consideration, the receipt and adequacy of which are hereby acknowledged, the parties hereto agree as follows:

1. Trademark Assignment. Assignor hereby sells, assigns, transfers, conveys, and delivers to Assignee, its successors and assigns, to have and to hold forever, and to freely reassign in the future at the Transferee's sole and absolute discretion, without warranty of any kind, express or implied being made by this Assignment Agreement, all of Assignor's right and interest in and to the Trademarks, together with the goodwill of the business with which the Trademarks are used and that is symbolized by the Trademarks, and all rights of priority in the Trademarks in any country as may now or hereafter be granted to it by law, treaty or other international conventions, to the extent that such rights and goodwill exist; any and all legal actions and rights and remedies at law or in equity for past, present and future infringements, misappropriations, dilutions, or other violations of the Trademarks, including the right to sue for, collect, and retain all damages, profits, proceeds, and all other remedies associated therewith; and any and all income, royalties, damages, and payments now or hereafter due or payable with respect to the Trademarks, for Assignee's own use and enjoyment and for the use and enjoyment of Assignee's successors, assigns, or other legal representatives as fully and entirely as the same would have been enjoyed by Assignor if this Assignment has not been made (together, the "Assigned Trademarks").

2. Assumption. Assignee hereby assumes, and agrees to pay, perform and discharge when due, all of Assignor's obligations under the Assigned Trademarks.

3. Further Assurances. Each of the parties hereto will execute and deliver such additional documents, instruments, conveyances and assurances and take such further actions as may be reasonably required to carry out the provisions hereof and give effect to the transactions contemplated by this Assignment Agreement.

4. Governing Law. This Assignment Agreement, and all claims or causes of action (whether in contract or tort) that may be based upon, arise out of, or relate to this Assignment Agreement or the negotiation, execution or performance of this Assignment Agreement, shall be governed solely by and construed in accordance with the internal laws of the State of Delaware, without regard to the conflict-of-law principles thereof.


