## TERMINATION AND RELEASE OF TRADEMARK SECURITY AGREEMENT

This TERMINATION AND RELEASE OF TRADEMARK SECURITY AGREEMENT, dated October 28, 2019 (the "Release"), is made by HSBC BANK USA, NATIONAL ASSOCIATION, as administrative agent (in such capacity, the "Administrative Agent") and as an issuing bank under the Credit Agreement (as defined below) in favor of MEDIDATA SOLUTIONS, INC. ("Medidata") and INTELEMAGE, LLC (together with Medidata, the "Companies", and each a "Company").

WHEREAS, pursuant to that certain (i) Credit Agreement, dated as of December 21, 2017 (as amended, supplemented, amended and restated or otherwise modified from time to time, the "Credit Agreement"), among Medidata, the lenders party thereto and the Administrative Agent, (ii) Pledge and Security Agreement, dated as of December 21, 2017 (as amended, supplemented, amended and restated or otherwise modified from time to time, the "Pledge and Security Agreement"), among the Companies and each other grantor party from time to time thereto in favor of the Administrative Agent and (iii) Trademark Security Agreement, dated as of December 21, 2017 (as amended, supplemented, amended and restated or otherwise modified from time to time, the "Trademark Security Agreement", and together with the Credit Agreement and the Pledge and Security Agreement, the "Agreements"), made by the Companies in favor of the Administrative Agent, each Company granted a continuing security interest (the "Security Interest") in all of the Trademark Collateral (as defined in the Trademark Security Agreement), all to the extent set forth in the Agreements;

WHEREAS, the Trademark Security Agreement was recorded with the United States Patent and Trademark Office ("USPTO") on January 2, 2018 at reel/frame numbers 006240/0509 and 006240/0631; and

WHEREAS, the Administrative Agent has agreed to release the Security Interest in the Trademark Collateral, including with respect to the certain trademark registrations and trademark applications set forth on the attached Schedule A (the "Specified Trademarks") and has duly authorized the execution, delivery and performance of this Release.

NOW THEREFORE, in consideration of the foregoing and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, and intending to be legally bound, the Administrative Agent hereby agrees as follows:

SECTION 1. Release of Security Interest. The Administrative Agent hereby releases its Security Interest held in the Trademark Collateral (including with respect to the Specified Trademarks) and hereby (i) terminates all its rights, powers, privileges and remedies under the Agreements with respect to the Trademark Collateral (including with respect to the Specified Trademarks), (ii) re-conveys, re-transfers, re-assigns and sets over to each Company any right, title or interest that the Administrative Agent may have acquired in the Trademark Collateral (including with respect to the Specified Trademarks), together with all the goodwill associated therewith, and (iii) releases each Company from all covenants, obligations, liabilities and warranties under the Agreements related to the Trademark Collateral (including with respect to the Specified Trademarks).

SECTION 2. Recordation. This Release has been executed and delivered by the Administrative Agent for the purpose of releasing the Security Interest of the Administrative Agent in the Trademark Collateral with the USPTO. The Administrative Agent hereby authorizes each Company, or such Company's authorized representative or designee, to record this Release with the USPTO.

SECTION 3. Further Assurances. The Administrative Agent hereby agrees to duly execute and deliver to each Company (or its designees) any further documents and to do such other acts that such Company (or their respective agents or designees) reasonably request, at such Company's sole cost and expense, in order to confirm this Release and such Company's right, title and interest in the Trademark Collateral.

SECTION 4. Counterparts. This Release may be executed by the parties hereto in several counterparts, each of which shall be deemed to be an original and all of which shall constitute together but one and the same agreement.




