## **RELEASE OF TRADEMARK RIGHTS**

THIS RELEASE dated as of October 30, 2019 (this "Release") is made by GOLDMAN SACHS PRIVATE MIDDLE MARKET CREDIT LLC, acting in its capacity as collateral agent for the Secured Parties (in such capacity, the "Collateral Agent") under that certain Security Interest in Trademark Rights, dated as of June 8, 2017 (as amended, supplemented or modified and in effect from time to time, the "Trademark Agreement") between CONTINUUM MANAGED SERVICES HOLDCO, LLC and RISOFT LLC (collectively, the "Grantors") and the Collateral Agent. Capitalized terms used but not defined herein have the meanings provided in the Trademark Agreement.

WHEREAS, pursuant to the Trademark Agreement, each Grantor granted to the Collateral Agent a continuing security interest in all of such Grantor's right, title and interest in, to and under its owned or thereafter acquired Trademark Collateral, including those set forth on the attached **Schedule A**;


WHEREAS, each Grantor has requested and the Collateral Agent has agreed to provide a document suitable for recording in the United States Patent and Trademark Office evidencing and effecting the release, relinquishment and discharge of its security interest in the Trademark Collateral (the "Released Collateral").

NOW, THEREFORE, for good and valuable consideration, the receipt of which is hereby acknowledged, the Collateral Agent does hereby, in each case, without recourse, representation or warranty of any kind whatsoever, (a) terminate the liens and security interest created under the Trademark Agreement in the Released Collateral, (b) release its security interest in the Released Collateral, (c) discharge any and all rights, title and interest it has in and the security interest granted to the Collateral Agent in the Released Collateral, and (d) reassigns, grants and conveys to the Grantors any and all right, title and interest it has in the Released Collateral.
