**RELEASE OF SECURITY INTEREST IN TRADEMARK COLLATERAL**

This RELEASE OF SECURITY INTEREST IN TRADEMARK COLLATERAL (the “Release”), dated as of October 30, 2019, is made by GOLDMAN SACHS BANK USA, as administrative agent (the “Administrative Agent”). Capitalized terms used but not defined herein have the meanings assigned to them in the Security Agreement (as defined below).

**WHEREAS**, THE DRESS BARN, INC., a Connecticut corporation (“Dress Barn”), the other Loan Parties, and the Administrative Agent, entered into that certain Guaranty and Collateral Agreement, dated as of August 21, 2015 (as amended, restated, supplemented or otherwise modified from time to time, the “Security Agreement”).

**WHEREAS**, pursuant to the Security Agreement, Dress Barn and the other Loan Parties executed and delivered to the Administrative Agent (i) that certain Patent and Trademark Security Agreement, dated as of August 21, 2015 (the “2015 Patent and Trademark Security Agreement”), and recorded with the U.S. Patent and Trademark Office on August 21, 2015 at Reel/Frame No. 5604/0713, (ii) that certain Trademark Security Agreement, dated as of April 28, 2016 (the “Trademark Security Agreement”), and recorded with the U.S. Patent and Trademark Office on April 28, 2016 at Reel/Frame No. 5780/0758; and iii) that certain Patent and Trademark Security Agreement, dated as of June 19, 2018 (the “2018 Patent and Trademark Security Agreement” and collectively with the 2015 Patent and Trademark Security Agreement and the Trademark Security Agreement, the “Patent and Trademark Security Agreements”), and recorded with the U.S. Patent and Trademark Office on June 19, 2018 at Reel/Frame No. 6357/0795, pursuant to which they collaterally assigned and pledged to the Administrative Agent, its successors and assigns, for the benefit of the Secured Parties, a security interest in, all of their right, title and interest in, to and under any and all of the Patent and Trademark Collateral (as defined in the 2015 Patent and Trademark Security Agreement and 2018 Patent and Trademark Security Agreement) and the Trademark Collateral (as defined in the Trademark Security Agreement);

**WHEREAS**, the Administrative Agent has acknowledged that, upon any sale or other transfer by Dress Barn of the Released Collateral (as defined below) in a transaction permitted under the Credit Agreement, all security interests granted in favor of the Administrative Agent pursuant to the Security Agreement and the other Collateral Documents in the Released Collateral shall immediately and automatically terminate pursuant to Section 9.16 of the Credit Agreement and Section 9.14(c) of the Security Agreement;

**WHEREAS**, the Administrative Agent has agreed to evidence the release of any security interest it may have in all of the right, title, and interest in and to the trademark registrations and applications owned by Dress Barn set forth in Schedule I attached hereto and incorporated herein by this reference (the “Released Collateral”), and to evidence the reassignment of any and all of its right, title, and interest in and to the Released Collateral to Dress Barn; and

**WHEREAS**, the security interest in the remaining Patent and Trademark Collateral and Trademark Collateral not owned by Dress Barn and granted to the Administrative Agent pursuant to the Patent and Trademark Security Agreements (the “Remaining Collateral”), will be unaffected by this Release and such security interest in the Remaining Collateral will continue in full force and effect.

**NOW, THEREFORE**, for and in consideration of the foregoing, and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, and upon the terms set forth in this Release, the Administrative Agent, on behalf of itself, its successors and assigns, and the Secured Parties, hereby **TERMINATES**, without recourse, representation, or warranty of any kind or nature the security interest in the Released Collateral, **RELEASES** and forever discharges, without recourse, representation, or warranty of any kind or nature its security interest in the Released Collateral, and retransfers and reassigns to Dress Barn any right, title or interest the Administrative Agent may have in, to or under the Released Collateral, without representation or warranty. The Administrative Agent shall retain its security interest in all other portions of the Patent and Trademark Collateral and Trademark Collateral that are not the Released Collateral that is the subject of this Release.


