**RELEASE OF SECURITY INTEREST IN  
UNITED STATES TRADEMARKS**

This Release of Security Interest ("Release"), effective as of the last dated signature below (the "Effective Date"), is entered into by and between RWJ Education Company II, L.L.C. a California limited liability company ("RWJ EC II") having a place of business at 1300 Evans Ave, No. 880154, San Francisco, CA 94188 and AVENUES WORLD HOLDINGS LLC, a Delaware limited liability company ("Avenues") having its principal place of business at 11 E. 26th Street, 17th Floor, New York, NY 10010.

WHEREAS, Avenues granted a certain Security Interest in favor of RWJ EC II, effective June 16, 2016, which (a) granted RWJ EC II a security interest in the trademark registration set forth on Schedule A, hereto; and (b) was recorded with the Assignments Branch of the United States Patent and Trademark Office at Reel 5819, Frame 0525 on June 22, 2016 (the "Security Interest"); and

WHEREAS, Avenues has satisfied all obligations relating to the Security Interest granted to RWJ EC II; and

WHEREAS, the parties desire to confirm the release of the Security Interest;

NOW THEREFORE, in consideration of the foregoing recitals (which are incorporated into and made a part of this Release), the covenants set forth below and for other good and valuable consideration, the sufficiency of which are hereby acknowledged, the parties hereby agree as follows:

1. Release of Security Interest. RWJ EC II hereby releases, terminates and extinguishes the Security Interest in and to the trademark registrations set forth on Schedule A, hereto (the "Trademarks"), as originally recorded at Reel 5819, Frame 0525 of the Assignments Branch, and further disclaims any and all ownership interest in and to the Trademarks in favor of Avenues.

2. Further Assurances. RWJ EC II will take such further reasonable action as may be requested by Avenues to confirm the release of the Security Interest and to acknowledge Avenues's ownership of all right, title and interest in and to the Trademarks, at sole cost and expense of Avenues.


