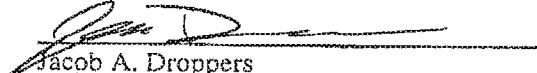

This Amended and Restated Certificate of Formation of Altway Insurance, LLC (the "LLC"), dated September 6, 2019, has been fully executed and is being filed by Jacob A. Droppers, as an authorized person, in accordance with the Delaware Limited Liability Company Act (6 De. C. § 18-208), to amend and restate the original Certificate of Formation of the LLC, which was filed under the name "Altway Insurance, LLC" on July 19, 2019, with the Secretary of State of the State of Delaware, as heretofore amended (the "Certificate"), to form a limited liability company under the Delaware Limited Liability Act (6 De. C § 18-101, et seq.).

This Certificate is hereby amended and restated in its entirety to read as follows:

- FIRST:** The name of the limited liability company is Altway Holdings, LLC.
- SECOND:** The address of its registered office in the State of Delaware is 251 Little Falls Drive, New Castle County, City of Wilmington, Delaware, Zip Code 19808. The name of the Registered Agent at such address is Corporation Service Company.
- THIRD:** The business of the limited liability company shall be managed by and under the authority of one or more managers. The manager(s) shall not have the power to take any action contrary to the express provisions of the Delaware Limited Liability Company Act, this Certificate of Formation, or the Company's Operating Agreement.
- FOURTH:** The life of the Company shall be perpetual.
