**TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS**

THIS TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS, dated as of October 28, 2019, is made by Wells Fargo Bank, National Association, in its capacity as collateral agent (the "Agent") for the several banks and other financial institutions (the "Lenders") from time to time parties to the Credit Agreement, dated as of December 6, 2016 (as amended, supplemented or otherwise modified from time to time, the "Credit Agreement"), among the Borrower, the other Borrowers from time to time party thereto, PRA Health Sciences, Inc., a Delaware corporation, the Lenders party thereto and the Agent, in favor of PRA Holdings, Inc., ReSearch Pharmaceutical Services, Inc., Lifetree Clinical Research, L.C. and Nextrials, Inc. (the "Grantors"). Capitalized terms used herein and not otherwise defined have the meanings specified in the Credit Agreement or the Security Agreement (as defined below), as applicable.

WITNESSETH:

WHEREAS, in connection with the Credit Agreement, the Grantors, the Borrower and the Subsidiaries that are party thereto, executed and delivered a Security Agreement, dated as of December 6, 2016 in favor of the Agent (as amended, restated, supplemented or otherwise modified from time to time, the "Security Agreement"), pursuant to which the Grantors pledged and granted to the Agent for the benefit of the Agent and the Secured Parties a continuing security interest in all Intellectual Property, including the Trademarks;

WHEREAS, pursuant to the Security Agreement, the Grantors executed and delivered that certain Grant of Security Interest in Trademark Rights, dated as of December 6, 2016, by and among the Grantors and the Agent (the "Trademark Security Agreement");

WHEREAS, pursuant to the Trademark Security Agreement and to secure the payment, performance and observance of the Obligations, each Grantor granted to the Agent for the benefit of the Secured Parties, a security interest in all of such Grantor's right, title and interest in, to and under the Trademarks (including, without limitation, those items listed on Schedule A hereto), including the right to receive all Proceeds therefrom, but excluding applications in the United States Patent and Trademark Office to register trademarks or service marks on the basis of Grantor's "intent to use" such trademarks or service marks unless and until an amendment to allege use or a statement of use has been filed and accepted under 15 U.S.C. §1051 and accepted by the United States Patent and Trademark Office (collectively, the "Trademark Collateral");

WHEREAS, the Trademark Security Agreement was recorded in the United States Patent and Trademark Office on December 6, 2016 at Reel 5947, Frame 0433 (with respect to PRA Holdings, Inc.); at Reel 5947, Frame 0477 (with respect to ReSearch Pharmaceutical Services, Inc.); at Reel 5949, Frame 0220 (with respect to Lifetree Clinical Research, L.C.); and at Reel 5949, Frame 0228 (with respect to Nextrials, Inc.);

WHEREAS, the Agent acknowledges full payment, performance and observance of the Obligations, and accordingly, the Agent now desires to terminate and release the entirety of its security interest in the Trademark Collateral;





