CERTIFICATE OF AMENDMENT
OF
THIRD AMENDED AND RESTATED
CERTIFICATE OF INCORPORATION
OF
CREW BY TRUE ROWING, INC.

Crew By True Rowing, Inc., a corporation organized and existing under and by virtue of the General Corporation Law of the State of Delaware (the "Corporation"), does hereby certify as follows:

1. The Board of Directors of the Corporation duly adopted a resolution by written consent in accordance with Sections 141(f) and 242 of the General Corporation Law of the State of Delaware, setting forth an amendment to the Third Amended and Restated Certificate of Incorporation of the Corporation (the "Certificate of Incorporation") and declaring said amendment advisable. The stockholders of the Corporation duly approved said proposed amendment by written consent in accordance with Sections 228 and 242 of the General Corporation Law of the State of Delaware. The resolution setting forth the amendment is, and the Certificate of Incorporation is hereby amended, as follows:

RESOLVED: That the Certificate of Incorporation of the Corporation is hereby amended by deleting Article FIRST thereof in its entirety and by substituting in lieu of said Article the following new Article:

"FIRST: The name of the corporation is: Hydrow, Inc. (the "**Corporation**")."

RESOLVED: That the first sentence of Article FOURTH of the Certificate of Incorporation be and hereby is deleted in its entirety and replaced with the following in lieu thereof:

"FOURTH: The total number of shares of all classes of stock which the Corporation shall have authority to issue is (i) 35,000,000 shares of Common Stock, \$0.0001 par value per share ("**Common Stock**") and (ii) 21,665,294 shares of Preferred Stock, \$0.001 par value per share ("**Preferred Stock**"), 5,562,911 of which are designated "**Series Seed Preferred Stock**," 3,144,873 of which are designated "**Series Seed Prime Preferred Stock**," and 12,957,510 of which are designated "**Series A Preferred Stock**"."

2. All other provisions of the Certificate of Incorporation shall remain in full force and effect.
