RELEASE OF SECURITY INTEREST IN TRADEMARKS

THIS RELEASE OF SECURITY INTEREST IN TRADEMARKS dated as of October 31, 2019 (this "Release") is made by Comerica Bank, as Agent (the "Secured Party"), under the Amendment to Trademark Security Agreement dated as of May 24, 2018 (as amended, restated, supplemented or otherwise modified from time to time, the "Security Agreement") by and between the Secured Party and Relevant Solutions, LLC, TMEC Distribution, LLC and ARD Distribution, LLC (each, a "Debtor" and together, the "Debtors") and recorded May 30, 2018 in the records of the United States Patent and Trademark Office at Trademark Reel 6338, Frame 0134.

Pursuant to the Security Agreement, the Debtors granted to the Secured Party a security interest ("Security Interest") in the Debtors' trademark collateral, including but not limited to the trademarks listed on attached Exhibit A (the "Released Trademarks").

The Secured Party now wishes to release and terminate the Security Interest in the Released Trademarks.

THEREFORE, for good and valuable consideration, the receipt of which is hereby acknowledged, the Secured Party hereby (i) terminates the Security Agreement and the Joinder Agreement, (ii) releases and terminates the Security Interest in the Released Trademarks and (iii) authorizes the recordation of this Release by the Debtors of their designee with the United States Patent and Trademark Office.


This Release shall be governed by and construed in accordance with the laws of the State of Texas without regard to conflicts of law principles.
