RELEASE OF SECURITY INTEREST IN TRADEMARKS

THIS RELEASE OF SECURITY INTEREST IN TRADEMARKS dated as of October 31, 2019 (this "Release") is made by Comerica Bank, as Agent (the "Secured Party"), under the Security Agreement dated as of December 31, 2010 (as amended, restated, supplemented or otherwise modified from time to time, the "Security Agreement") by and between the Secured Party and Relevant Solutions, LLC (f/k/a LKCM Distribution, LLC), LKCM WM Distribution, LLC, LKCM CPI Distribution, LLC, LKCM WM Intec, LLC and LKCM Distribution Holdings, L.P. (each, a "Debtor" and together, the "Debtors"), and under the Joinder Agreement (Security Agreement) dated as of December 21, 2012 (the "Joinder Agreement") by and between Secured Party, ARD Distribution, LLC and ARD International, LLC (each, also a "Debtor" and together, the "Debtors") and recorded April 11, 2013 in the records of the United States Patent and Trademark Office at Trademark Reel 5004, Frame 0506. Comerica Bank has assigned its interest in the Security Agreement to Comerica Bank, as Agent, as shown in the records of the United States Patent and Trademark Office at Trademark Reel 5671, Frame 0767.

Pursuant to the Security Agreement and the Joinder Agreement, the Debtors granted to the Secured Party a security interest ("Security Interest") in the Debtors' trademark collateral, including but not limited to the trademarks listed on attached Exhibit A (the "Released Trademarks").

The Secured Party now wishes to release and terminate the Security Interest in the Released Trademarks.

THEREFORE, for good and valuable consideration, the receipt of which is hereby acknowledged, the Secured Party hereby (i) terminates the Security Agreement and the Joinder Agreement, (ii) releases and terminates the Security Interest in the Released Trademarks and (iii) authorizes the recordation of this Release by the Debtors of their designee with the United States Patent and Trademark Office.


This Release shall be governed by and construed in accordance with the laws of the State of Texas without regard to conflicts of law principles.
