PARTIES

HEALTHERIES OF NEW ZEALAND LIMITED (NZBN 9429040706665), a New Zealand company of Cnr Kordel Place and Accent Drive, East Tamaki, New Zealand (**Assignor**)

VITACO HEALTH IP PTY LIMITED (ACN 607 496 542), an Australian company of Level 3, 68 Waterloo Road, North Ryde, NSW 2113, Australia (**Assignee**)

INTRODUCTION

- A. The Assignor is the registered proprietor of the Trade Mark registration set out in the Schedule (**Trade Mark**).
- B. The Assignor assigned to the Assignee all of the Assignor's rights, title and interest in and to the Trade Mark under a Deed of Assignment dated 7 April 2016 (**Deed of Assignment**).
- C. The Assignor has agreed to confirm such assignment under the Deed of Assignment, on the terms and conditions of this deed.

COVENANTS

1. ASSIGNMENT

- 1.1 **Confirmation:** In consideration of the sum of NZ\$1.00 paid by the Assignee to the Assignor and other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged by the Assignor, the Assignor hereby confirms the assignment by the Assignor to the Assignee of all of the Assignor's rights, title and interest in and to the Trade Mark under the Deed of Assignment, together with the goodwill symbolised by and associated with the Trade Mark.

2. GENERAL

- 2.1 **Further assurances:** The Assignor agrees to do all things and execute any further documents that may be required to give effect to the assignments confirmed and effected in this deed.
- 2.2 **Waiver:** No failure or delay by any party in exercising any right, power or privilege under this deed will operate as a waiver of such right, power or privilege, nor will any single or partial exercise preclude any other or further exercise of any right, power or privilege under this deed.
- 2.3 **Counterparts:** This deed may be executed in any number of counterparts (including facsimile copies or electronically scanned copies) all of which, when taken together, will constitute one and the same instrument. A party may enter into this deed by executing any counterpart.
- 2.4 **Governing law:** The formation, validity, construction and performance of this deed will be governed by and construed in accordance with the laws in force in New South Wales, Australia. The parties irrevocably agree that the Courts exercising jurisdiction in New

South Wales will have non-exclusive jurisdiction to hear and determine all disputes under or in connection with this deed


