**TERMINATION AND RELEASE OF
GRANT OF A SECURITY INTEREST -- TRADEMARKS**

This Termination and Release of Grant of a Security Interest - Trademarks (this "Termination"), dated as of October 31, 2019, is executed by QVT Fund LP, a Cayman Islands limited partnership ("QVT Fund"), and Quintessence Fund L.P., a Cayman Islands limited partnership ("Quintessence", and together with QVT Fund and their respective successors and assigns in such capacity, "Grantees"), in favor of Aehr Test Systems, a California corporation ("Grantor"). All capitalized terms used in this Termination and not otherwise defined herein, shall have the respective meanings given to such terms in the Security Agreement (defined below).

RECITALS

A. Pursuant to that certain Grant of a Security Interest - Trademarks, dated as of April 10, 2015 (as amended, the "Security Agreement"), by and between Grantor and Grantees, Grantor granted to Grantees a security interest in the Trademark Collateral (defined below).

C. The Security Agreement was recorded with the Trademark Division of the United States Patent and Trademark Office on April 14, 2015, at Reel/Frame 5497/0154, to evidence the security interest granted under the Security Agreement.

D. Grantees agree to execute this Termination in order to evidence the termination and release of its security interest in the Trademark Collateral specified below.

AGREEMENT

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Grantees hereby agree as follows:

(a) Grantees expressly terminate and release all of Grantees' right, title and interest in, to and under the following (collectively, the "Trademark Collateral");

(i) the Trademarks, together with, among other things, the goodwill of the business symbolized by the Trademarks and the applications and registrations thereof, and all proceeds thereof, including, without limitation, any and all causes of action which may exist by reason of infringement thereof and any and all damage arising from past, present and future violations thereof.

(b) Grantees represent and warrant that they have the full power and authority to execute this Termination.


(c) Grantees authorize and request the Trademark Division of the United States Patent and Trademark Office to record this Termination.
