ASSIGNMENT AGREEMENT

Assignor hereby irrevocably assigns, conveys, sells, grants and transfers to Assignee, its successors and assigns in perpetuity all of its rights, title and interest of every kind and character throughout the world, including moral rights, in and to the trade name(s) **Entreventure** to the full extent of its ownership or interest.
