**RELEASE OF SECURITY INTEREST IN TRADEMARK RIGHTS**

This Release of Security Interest in Trademark Rights, dated as of November 6, 2019 (the “Trademark Security Release”), is made by WILMINGTON TRUST, NATIONAL ASSOCIATION, as the Collateral Agent (in such capacity, the “Collateral Agent”), in favor of BLACKBOARD INC., a Delaware corporation (“Blackboard”), BLACKBOARD COLLABORATE INC., a Delaware corporation (“Blackboard Collaborate”), BLACKBOARD CONNECT INC., a North Carolina corporation (“Blackboard Connect”), EDLINE HOLDINGS, INC., a Delaware corporation (“Edline”), EDLINE LLC, a Delaware limited liability company (“Edline LLC”), BLACKBOARD OPEN LMS, INC. (F/K/A MOODLEROOMS, INC.), a Delaware corporation (“Blackboard Open LMS”), PARLANT TECHNOLOGY, INC., a Utah corporation (“Parlant”), MYEDU CORPORATION, a Delaware corporation (“Myedu”), SCHOOLWIRES, INC., a Delaware corporation (“Schoolwires”) and TEACHERWEB, INC., a Delaware corporation (“Teacherweb” and together with Blackboard, Blackboard Collaborate, Blackboard Connect, Edline, Edline LLC, Blackboard Open LMS, Parlant, Myedu and Schoolwires, individually, each a “Grantor” and collectively, the “Grantors”). Capitalized terms used and not defined herein have the meanings given to such terms in the Indenture and the Security Agreement, as applicable (each, as defined below).

Reference is made to the Second Lien Collateral Agreement, dated as of October 18, 2016 (as amended, restated, amended and restated, supplemented or otherwise modified prior to the date hereof, the “Security Agreement”), among Blackboard (the “Issuer”), the subsidiaries of the Issuer from time to time party thereto and the Collateral Agent. The Issuer issued Notes and the Issuer and the Collateral Agent entered into that certain Indenture, dated as of October 18, 2016 (as amended, restated, amended and restated, supplemented or otherwise modified prior to the date hereof, the “Indenture”), for the benefit of each other and for the equal and ratable benefit of the Holders.

WHEREAS, pursuant to the Security Agreement, the Grantors granted to the Collateral Agent for the benefit of the Collateral Agent and the Holders a continuing security interest in all of such Grantor’s right, title and interest in, to and under certain intellectual property, including the Trademark Collateral (as defined in the Trademark Security Agreement referred to below);

WHEREAS, in connection with the Security Agreement, the Grantors executed and delivered that certain Second Lien Trademark Security Agreement dated as of October 18, 2016 made by the Grantors, in favor of the Collateral Agent (the “Trademark Security Agreement”) for recording with the United States Patent and Trademark Office;

WHEREAS, the Trademark Security Agreement was recorded in the United States Patent and Trademark Office on October 20, 2016 on Reel/Frame 5904/0926;

WHEREAS, the Obligations secured by the Trademark Collateral have been repaid or otherwise satisfied; and

WHEREAS, the Collateral Agent therefore is requested to release, terminate and discharge its Lien and continuing security interest in all of Grantors’ right, title and interest in, to

and under the Trademark Collateral and grant all of its right, title and interest in, to and under the Trademark Collateral to the Grantors.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the Collateral Agent hereby agrees as follows:

1. Without recourse, representation or warranty, the Collateral Agent hereby releases, terminates and discharges to the Grantors (a) the Collateral Agent's continuing security interest in, right of setoff against and Lien on, and (b) any of the Collateral Agent's other rights, title or interest of any kind or nature in, to or under, the Trademark Collateral, including, without limitation, the Trademarks listed on Schedule 1 hereto.

2. The Collateral Agent hereby authorizes and acknowledges the termination of the Trademark Security Agreement and authorizes the Grantors or any of their agents or designees to record this Trademark Security Release with the United States Patent and Trademark Office and any other offices as may be necessary to carry out the intention of this Trademark Security Release. At Grantors' expense, the Collateral Agent hereby agrees to duly execute, acknowledge, procure and deliver any further documents and to do such other acts as may be reasonably necessary to effect the release of the security interest contemplated hereby and terminate the Trademark Security Agreement.

3. This Trademark Security Release shall be governed by, and construed in accordance with, the laws of the state of New York (without giving effect to the conflict of laws principles thereof).

4. Delivery of an executed counterpart of a signature page to this Trademark Security Release by facsimile or other electronic transmission (including ".pdf" or ".tif" format) will be as effective as delivery of a manually executed counterpart of this Trademark Security Release.


