RELEASE OF PATENT AND TRADEMARK SECURITY INTERESTS dated as of November 6, 2019 (this “Release”), by BANK OF AMERICA, N.A., as Collateral Agent (the “Collateral Agent”). B. Pursuant to the Security Agreements, the Grantors granted a security interest to the Collateral Agent, for the benefit of the Secured Parties, in, among other things, the patents of the Grantors set forth on Schedule I hereto (the “Patents”) and the trademarks of the Grantors set forth on Schedule II hereto (the “Trademarks”).

C. In connection with the termination of the Credit Agreement, the Grantors have requested that the Collateral Agent release all right, title and interest granted to it, for the benefit of the Secured Parties, under the Security Agreements in and to the Patents and the Trademarks.

Accordingly, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Collateral Agent hereby terminates, releases and discharges any and all security interests it has in the Patents and the Trademarks under the Security Agreements. This Release is made without representation or warranty by, or recourse to, the Collateral Agent or any other Secured Party.




