## TRADEMARK ASSIGNMENT

**THIS TRADEMARK ASSIGNMENT** ("Assignment") is made and entered into as of this 9<sup>th</sup> day of October, 2019 ("Effective Date"), by and between Astellas Pharma Inc., a Japanese corporation located at 5-1, Nihonbashi-Honcho 2-chome, Chuo-ku Tokyo, 103-8411, Japan ("Assignor"), and Astellas US LLC, a Delaware corporation located at 1 Astellas Way Northbrook, IL 60060 ("Assignee"). Assignor and Assignee may each be referred to herein as a "Party" and collectively as the "Parties."

**WHEREAS**, Assignor is the sole and exclusive owner of the U.S. federal registration set forth on Exhibit A attached hereto and made part hereof (the "Mark"); and


**WHEREAS**, Assignee wishes to acquire from Assignor, and Assignor wishes to assign, transfer, convey and deliver to Assignee, the Mark, together with all common law rights therein and all goodwill of the business associated with and symbolized by the Mark;

**NOW, THEREFORE**, in consideration of the foregoing, and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Parties, intending to be legally bound, do hereby agree as follows:

I. Conveyance and Acceptance of Mark. Effective as of the Effective Date, (a) Assignor hereby irrevocably, without reservation, assigns, transfers, conveys and delivers to Assignee (and to Assignee's successors and assigns), all of its right, title and interest in and to the Mark, including all common law rights therein and the U.S. federal registrations and pending applications set forth on Exhibit A attached hereto, together with all proceeds, benefits, privileges, causes of action, and remedies relating to the Mark, all rights to bring an action, whether at law or in equity, for infringement, dilution, misappropriation, misuse or other violation of the Mark against any third party, all rights to recover damages, profits and injunctive relief for all past, present or future infringement, dilution, misappropriation, misuse, or other violation of the Mark, and all goodwill of the business associated with and symbolized by the Mark, and (b) Assignee hereby accepts such assignment, transfer, conveyance, and delivery.


