**TERMINATION OF  
TRADEMARK SECURITY AGREEMENT**

This Termination of Trademark Security Agreement (this "Termination"), dated as of November 7, 2019, is executed by Solar Capital Ltd., in its capacity as collateral agent (the "Secured Party") in favor of Restoration Robotics, Inc., a Delaware corporation (the "Company").

RECITALS

WHEREAS, the Company entered into a certain Intellectual Property Security Agreement dated as of May 10, 2018 (the "Security Agreement");

WHEREAS, in connection with the Security Agreement, the Company entered into a certain Short-Form Trademark Security Agreement dated as of May 10, 2018 (the "Short-Form Security Agreement") and recorded it with the U.S. Patent and Trademark Office ("USPTO") on May 10, 2018 at Reel/Frame No. 6329/0122; and

WHEREAS, pursuant to the Security Agreement, the Company granted to the Secured Party a security interest in certain Intellectual Property Collateral including certain trademarks and trademark applications;

WHEREAS, pursuant to the Short-Form Security Agreement, the Company granted to the Secured Party a security interest in certain collateral, including certain trademarks and trademark applications; and

WHEREAS, the Intellectual Property Collateral in the Security Agreement has been released, including all of the trademarks and trademark applications described in the Security Agreement, and the collateral in the Short-Form Security Agreement has been released, including all of the trademarks and trademark applications described in the Short-Form Security Agreement. Accordingly, the Security Agreement and the Short-Form Security Agreement are to be terminated.

NOW, THEREFORE, the Secured Party agrees as follows:

1. All capitalized terms used herein but not otherwise defined herein shall have the meaning given to them in the Security Agreement.
2. The Secured Party is executing and delivering this Termination as evidence of the termination of the Security Agreement and of the termination of the Short-Form Security Agreement.
3. The Secured Party, without representation, warranty, or recourse, hereby:
  - (a) terminates, cancels, discharges, and releases the security interest in all of its right, title and interest in, to, and under all the trademarks, whether now owned or at any time hereafter acquired, of the Company that are registered with, or for which applications for registration have been filed with, the USPTO, including the trademarks listed on the


attached Schedule of Registered Trademarks, and all registrations and pending applications associated therewith; and

(b) authorizes the recordation of this Termination with the USPTO.



