The corporation organized and existing under and by virtue of the General Corporation Law of the State of Delaware does hereby certify:



"FIRST. The name of the corporation (hereinafter sometimes referred to as the "Corporation") is: Aludyne North America, Inc."


SECOND: That said amendment was duly adopted in accordance with the provisions of Section 242 of the General Corporation Law of the State of Delaware.
