**RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY**

This **RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY** (this "Release") is dated as of November 6, 2019 by CROSSFIRST BANK (the "Grantee"), CrossFirst Bank, a Kansas state-chartered bank, located at 4435 Main Street, Suite 1100, Kansas City, MO 64111, in favor of FUTURECAST, LLC (the "Grantor"), located at 1740 Main Street, Kansas City, MO 64108. All capitalized terms used but not otherwise defined herein have the meanings given to them in the Security Agreement (as defined below).

**WHEREAS**, the Grantor and the Collateral Agent entered into that certain Loan and Security Agreement, dated as of August 30, 2019 (the "Security Agreement"), pursuant to which the Grantor executed and delivered to the Grantee that certain Notice of Intellectual Property Security Interest, dated as of August 30, 2019 (the "IP Notice"), for recordation with the United States Patent and Trademark Office and any other appropriate domestic governmental authorities, as applicable;

**WHEREAS**, with respect to the Trademarks list in Schedule A thereto, the IP Notice was recorded with the United States Patent and Trademark Office on September 6, 2019, in Reel 6737, Frame 0799;

**WHEREAS**, the Grantor has requested a release of the security interest granted in the trademark identified on Schedule I hereto (the "Released Trademark"); and

**WHEREAS**, the Grantee has agreed to terminate and release the security interest in the Released Trademark.

**NOW, THEREFORE**, for and in consideration of the foregoing, and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Grantee hereby agrees as follows:

The Grantee hereby terminates, releases and forever discharges the security interest in the Released Trademark, including or arising from the registrations and applications for registration of United States intellectual property listed on Schedule I, and retransfers and reassigns to the Grantor any right, title or interest of the Grantee in, to or under the Released Trademark.
