RELEASE OF SECURITY INTEREST IN TRADEMARKS

WHEREAS, the IP Agreement was duly recorded on November 1, 2016, at Reel 5923, Frame 0202 in the United States Patent and Trademark Office;



NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Grantee hereby releases, assigns and conveys, without recourse or warranty to Grantor all of its rights, title and interest in the Released Trademarks, and terminates, releases, discharges, quitclaims and relinquishes unto Grantor any and all security interests and liens it has against the Released Trademarks.
