TRADEMARK ASSIGNMENT

This Trademark Assignment is dated as of November 8, 2019 (the "Assignment") between Applied Visions, Inc., a corporation organized and existing under the laws of New York with an address of 6 Bayview Avenue, Northport, NY 11768 (hereinafter "Assignor"), and Code Dx, Inc., a corporation organized and existing under the laws of Delaware with an address of 6 Bayview Avenue, Northport, NY 11768 (hereinafter "Assignee").

1. Assignment. Assignor hereby assigns to Assignee all right, title and interest in and to the Marks, together with any goodwill associated therewith.
2. Rights and Privileges. All rights and privileges, including the right to sue for and receive all damages from past infringements of the Marks, will be held and enjoyed by Assignee and its successors, assigns and other legal representatives.
3. Further Assurances. Assignor agrees to execute and deliver at a future date any additional documents that Assignee reasonably determines are required to perfect Assignee's ownership of or title to the Marks.
4. Authorization. Assignor authorizes and requests any official whose duty is to register and record ownership in trademark registrations and applications for registration of trademarks, to record Assignee as the assignee and owner of any and all of Assignor's rights in the Marks.
5. Right to Convey. Assignor hereby covenants that it has the full right to convey the entire interest herein assigned and that it has not executed, and will not execute, any agreement in conflict herewith.
