**TERMINATION AND RELEASE OF
SECURITY INTEREST IN TRADEMARKS AND COPYRIGHTS**

This **TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS AND COPYRIGHTS**, dated as of October 30, 2019 ("Release"), is made by **EAGLEBANK**, a Maryland banking institution ("Secured Party"), in favor of **PROMONTORY INTERFINANCIAL NETWORK, LLC**, a Delaware limited liability company, "Promontory Interfinancial Network, LLC", and **PROMNETWORK SERVICES LLC**, a Delaware limited liability company ("Promnetwork Services LLC"); Promontory Interfinancial Network, LLC together with Promnetwork Services LLC, collectively, the "Grantor").

WHEREAS, pursuant to that certain Security Agreement dated as of September 22, 2011 (as amended, modified or supplemented from time to time, the "Security Agreement") by Grantor in favor of Secured Party and the Intellectual Property Security Agreement dated as of September 22, 2011 ("Intellectual Property Security Agreement") by the Grantor and Secured Party, Grantor granted and pledged to Secured Party a security interest in all of Grantor's right, title and interest in, to and under the Intellectual Property; and

WHEREAS, the Security Agreement was recorded at the United States Patent and Trademark Office ("USPTO") on September 22, 2011 at Reel 026953, Frame 0676 and on September 22, 2011 at Reel 4627 Frame 0919.

NOW THEREFORE, in consideration of the mutual promises and undertakings set forth herein and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, and with the intention of being legally bound hereby, Secured Party and Grantor agree as follows:

SECTION 1. Defined Terms. Capitalized terms used herein without definition shall have the meanings ascribed to such terms in the Security Agreement or Intellectual Property Security Agreement.

SECTION 2. Termination and Release. Secured Party hereby:

- (a) terminates the Intellectual Property Security Agreement;
- (b) terminates, cancels, forever discharges, and releases the security interest in all of Grantor's right, title and interest in, to and under the Intellectual Property, including, but not limited to, the foregoing listed on Schedule A attached hereto;
- (c) represents and warrants that it has full authority to execute and deliver this Release; and
- (d) authorizes the recordation of this Release with the USPTO at Grantor's expense.



Secured Party, at Grantor's expense, hereby agrees to duly execute, acknowledge, procure and deliver any further documents and to do such other acts as may be reasonably necessary to effect the security interest release contemplated herein. To the extent that any other filings with any other governmental authority have been made with respect to any of the Intellectual Property Collateral, Secured Party will, at Grantor's expense, execute and deliver a reasonable release or other instrument that will terminate any such filing and/or release any interests conveyed therein.
