Now therefore, in consideration of their mutual representations, the Parties set forth the following,

CLAUSES:

FIRST: PURPOSE. The ASSIGNOR hereby assigns and conveys to the ASSIGNEE absolutely and without restriction, all the rights and duties of the Trademarks described in declaration I (b) as well as the goodwill associated to the Trademarks.

As of this date, the ASSIGNOR agrees to stop all and any kind of use or exploit of the Trademarks, unless ASSIGNOR obtains a prior written permission duly executed by the ASSIGNEE.

SECOND: CONSIDERATION. The Parties agree that ASSIGNEE shall pay to ASSIGNOR a good and valuable consideration for assignment of the Trademarks described in declaration I (b).

THIRD: NOTICES. Each and every notice required or permitted by this agreement shall be in written and delivered personally or by certified mail or any other means where its reception

is featured and shall be considered as received after three natural days, and once delivery proof is obtained in the following domiciles:

In the event that any of the Parties change their domicile, such Party shall notify the other at least five days before the date such change is effective.

FOURTH: MODIFICATIONS. All terms and conditions herein contained constitute the entire agreement between the Parties and supersede all prior understanding, whether oral or written in connection with the purpose of this agreement, and no pact nor modifying or extending agreement, shall be bound to any of the Parties unless made in writing and signed by both parties, declaring that such modification shall be part of his Agreement.

FIFTH: JURISDICTION. Both Parties agree that for the interpretation and/or compliance hereof they shall submit to the jurisdiction of the competent Courts of Guadalajara, Jalisco, Mexico;

In execution of the foregoing, the Parties hereof recognize the content of each of the clauses in this Agreement; therefore both Parties hereby sign it in two identical counterparts.
