RELEASE OF SECURITY INTEREST IN TRADEMARKS

THIS RELEASE OF SECURITY INTEREST IN TRADEMARKS dated November 18, 2019 by BMO Harris Bank N.A., a national banking association, ("*BMO Harris*"), with its mailing address at 111 West Monroe Street, Chicago, Illinois 60603, acting as administrative agent (BMO Harris acting as such administrative agent being hereinafter referred to as the "*Assignee*");

WITNESSETH:

WHEREAS, BW Gas & Convenience Holdings, LLC ("*Assignor*"), with its mailing address at 138 Conant Street, Beverly, Massachusetts 01915, and Assignee were parties to a certain Confirmatory Assignment of Security Interest in United States Trademarks effective as of December 28, 2016 between Assignor and Assignee which was recorded in the United States Patent and Trademark Office on December 30, 2016 at Reel 5956, Frame 197 (the "*Agreement*"), pursuant to which Assignor confirmed its grant to Assignee of a security interest in, among other things, the trademarks, trademark registrations, and trademark applications listed on Schedule A attached hereto and certain other property (collectively, the "*Trademark Property*"); and

(i) each trademark, trademark registration, and trademark application listed on Schedule A hereto, and all of the goodwill of the business connected with the use of, and symbolized by, each such trademark, trademark registration, and trademark application, except that this document shall not operate as a sale, transfer, conveyance or other assignment of any intent to use trademark application to the extent that such application is pending without a Statement of Use having been filed and accepted, in which case this document shall operate only to release a security interest in such application; and

(ii) all proceeds of the foregoing, including without limitation any claim by Debtor against third parties for damages by reason of past, present or future infringement of any trademark, trademark registration, or trademark application listed on Schedule A hereto or by reason of injury to the goodwill associated with any such trademark, trademark registration, or trademark application, in each case together with the right to sue for and collect said damages.
